3 (1) Filing of an RBC report that indicates that the health 4 organization's total adjusted capital is greater than or equal 5 to its regulatory action level RBC but less than its company 6 action level RBC.

7 (1.1) Filing of an RBC report that indicates the health
8 organization's total adjusted capital is greater than or equal

9 to its company action level RBC but less than the product of its

10 authorized control level RBC and 3.0 and the health

11 organization's trend test result triggers regulatory attention

12 as determined in accordance with the Trend Test Calculation

13 <u>included in the RBC instructions.</u>

14 (2) Notification by the Insurance Department to a health 15 organization of an adjusted RBC report that indicates an event 16 under paragraph (1) or (1.1).
