## AN ACT

- Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An act to consolidate, editorially revise, and codify the public 2

- welfare laws of the Commonwealth," further providing for payments to counties for services to children.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:
- Section 1. Section 704.1(g) of the act of June 13, 1967 7
- 8 (P.L.31, No.21), known as the Public Welfare Code, added July 9,
- 1976 (P.L.846, No.148), is amended and the section is amended by
- 10 adding a subsection to read:
- 11 Section 704.1. Payments to Counties for Services to
- Children.--\* \* \* 12
- 13 (b.1) Payments shall be made in equal quarterly installments
- 14 of the amount fixed by section 709.3, the first of which shall
- 15 be for the quarter beginning July 1 and ending September 30; the
- 16 second installment shall be for the quarter beginning October 1
- and ending December 31; the third installment shall be for the 17

- 1 <u>quarter beginning January 1 and ending March 31; and the fourth</u>
- 2 <u>installment shall be for the quarter beginning April 1 and</u>
- 3 ending June 30; the local contribution required under this
- 4 section shall not be required to be paid until the fourth
- 5 <u>quarter payment is due. The quarterly payment shall be paid at</u>
- 6 the beginning of each quarter for which the county institution
- 7 <u>district or its successor has budgeted an amount equal to one</u>
- 8 <u>quarter of the annual local contribution required. At the close</u>
- 9 of the fourth quarter, the total payments made to the county
- 10 institution district or its successor in accordance with section
- 11 709.3 shall be reconciled and adjusted in accordance with this
- 12 section and section 709.3.

- 14 [(g) The department shall, within forty-five days of each
- 15 calendar quarter, pay fifty percent of the department's share of
- 16 the county institution district's or its successor's estimated
- 17 expenditures for that quarter.]

- 19 Section 2. This act shall take effect immediately.
