- 19 (a) Prohibition. -- The Commonwealth of Pennsylvania hereby
- 20 elects pursuant to the authority granted the states under
- 21 section 1303(a) of the Patient Protection and Affordable Care
- 22 Act (Public Law 111-148, 42 U.S.C. § 18023(b)) to prohibit
- 23 certain abortion coverage in qualified health plans offered
- 24 through the health insurance exchange under subsection (b).
- 25 (b) Included coverage prohibition. -- No qualified health plan
- 26 offered in this Commonwealth through the health insurance
- 27 exchange shall include coverage for the performance of any
- 28 abortion unless the reason the abortion is performed is one for
- 29 which the expenditure of public funds would be permitted under
- 30 18 Pa.C.S. § 3215(c) (relating to publicly owned facilities;

- 1 <u>public officials and public funds</u>) and the applicable reports
- 2 required under 18 Pa.C.S. § 3215(c) are made.
- 3 (c) Excluded coverage prohibited. -- No qualified health plan
- 4 offered in this Commonwealth through a health insurance exchange
- 5 <u>shall exclude coverage for treatment of any post-abortion</u>
- 6 <u>complication</u>.
- 7 (d) Option. -- Nothing in this section shall prohibit an
- 8 <u>individual from purchasing optional supplemental abortion</u>
- 9 coverage provided the individual pays a separate premium for the
- 10 coverage and obtains the coverage outside of the health
- 11 <u>insurance exchange</u>.
- 12 Section 3. This act shall take effect in 60 days.
