AN ACT

Amending Titles 18 (Crimes and Offenses), 30 (Fish) and 34 1 (Game) of the Pennsylvania Consolidated Statutes, in assault, 2 further providing for the offense of aggravated assault; in 3 enforcement, further providing for interference with officers 4 of the Pennsylvania Game Commission and of the Pennsylvania 5 Fish and Boat Commission; providing for the offense of 6 assaulting an officer; further providing for jurisdiction and 7 8 penalties and for disposition of fines and penalties; and, in 9 game or wildlife protection, further providing for killing game or wildlife to protect person, for unlawful importation 10 of game or wildlife and for unlawful taking and possession of 11 protected birds. 12
