AN ACT

- 1 Amending the act of November 30, 2004 (P.L.1672, No.213),
- entitled, "An act providing for the sale of electric energy
- generated from renewable and environmentally beneficial
- sources, for the acquisition of electric energy generated
- from renewable and environmentally beneficial sources by
- 6 electric distribution and supply companies and for the powers
- and duties of the Pennsylvania Public Utility Commission,"
- 8 further providing for alternative energy portfolio standards
- and for portfolio requirements in other states.
- 10 The General Assembly of the Commonwealth of Pennsylvania
- 11 hereby enacts as follows:
- 12 Section 1. Sections 3(b)(2) and 4 of the act of November 30,
- 13 2004 (P.L.1672, No.213), known as the Alternative Energy
- 14 Portfolio Standards Act, amended July 17, 2007 (P.L.114, No.35),

- 2 Section 3. Alternative energy portfolio standards.
- 3 * * *
- 4 (b) Tier I and solar photovoltaic shares.--
- 5 * * *
- 6 (2) The total percentage of the electric energy sold by
- 7 an electric distribution company or electric generation
- 8 supplier to retail electric customers in this Commonwealth
- 9 that must be sold from solar photovoltaic technologies is:
- 10 (i) 0.0013% for June 1, 2006, through May 31, 2007.
- 11 (ii) 0.0030% for June 1, 2007, through May 31, 2008.
- 12 (iii) 0.0063% for June 1, 2008, through May 31,
- 13 2009.
- 14 (iv) 0.0120% for June 1, 2009, through May 31, 2010.
- 15 (v) 0.0203% for June 1, 2010, through May 31, 2011.
- 16 (vi) 0.0325% for June 1, 2011, through May 31, 2012.
- 17 (vii) [0.0510%] 0.1500% for June 1, 2012, through
- 18 May 31, 2013.
- 19 (viii) [0.0840%] <u>0.1700%</u> for June 1, 2013, through
- 20 May 31, 2014.
- 21 (ix) [0.1440%] 0.2041% for June 1, 2014, through May
- 22 31, 2015.
- 23 (x) 0.2500% for June 1, 2015, through May 31, 2016.
- 24 (xi) 0.2933% for June 1, 2016, through May 31, 2017.
- 25 (xii) 0.3400% for June 1, 2017, through May 31,
- 26 2018.
- 27 (xiii) 0.3900% for June 1, 2018, through May 31,
- 28 2019.
- 29 (xiv) 0.4433% for June 1, 2019, through May 31,
- 30 2020.

1 (xv) 0.5000% for June 1, 2020, and thereafter.

4 Section 4. Portfolio requirements in other states.

- 5 <u>(a) General rule.--</u>If an electric distribution supplier or
- 6 electric generation company provider sells electricity in any
- 7 other state and is subject to renewable energy portfolio
- 8 requirements in that state, they shall list any such requirement
- 9 and shall indicate how it satisfied those renewable energy
- 10 portfolio requirements. To prevent double-counting, the electric
- 11 distribution supplier or electric generation company shall not
- 12 satisfy Pennsylvania's alternative energy portfolio requirements
- 13 using alternative energy used to satisfy another state's
- 14 portfolio requirements or alternative energy credits already
- 15 purchased by individuals, businesses or government bodies that
- 16 do not have a compliance obligation under this act unless the
- 17 individual, business or government body sells those credits to
- 18 the electric distribution company or electric generation
- 19 supplier. Energy derived from alternative energy sources inside
- 20 the geographical boundaries of this Commonwealth shall be
- 21 eligible to meet the compliance requirements under this act.
- 22 Energy derived from alternative energy sources located outside
- 23 the geographical boundaries of this Commonwealth but within the
- 24 service territory of a regional transmission organization that
- 25 manages the transmission system in any part of this Commonwealth
- 26 shall only be eligible to meet the compliance requirements of
- 27 electric distribution companies or electric generation suppliers
- 28 located within the service territory of the same regional
- 29 transmission organization. For purposes of compliance with this
- 30 act, alternative energy sources located in the PJM

- 1 Interconnection, L.L.C. regional transmission organization (PJM)
- 2 or its successor service territory shall be eligible to fulfill
- 3 compliance obligations of all Pennsylvania electric distribution
- 4 companies and electric generation suppliers. Energy derived from
- 5 alternative energy sources located outside the service territory
- 6 of a regional transmission organization that manages the
- 7 transmission system in any part of this Commonwealth shall not
- 8 be eligible to meet the compliance requirements of this act.
- 9 Electric distribution companies and electric generation
- 10 suppliers shall document that this energy was not used to
- 11 satisfy another state's renewable energy portfolio standards.
- 12 (b) Solar photovoltaic technology. -- To meet the requirements
- 13 of this section, all solar photovoltaic technology registered
- 14 after January 1, 2012, shall directly deliver the electricity it
- 15 generates to the distribution system operated by an electric
- 16 distribution company operating within this Commonwealth and
- 17 currently obligated to meet the compliance requirements
- 18 contained in this act.
- 19 Section 2. This act shall take effect in 60 days.
