AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in snowmobiles and all-terrain vehicles, further
- providing for registration of snowmobile or ATV, for
- 4 certificate of title for snowmobile or ATV, for fees and for
- records; and providing for vintage snowmobile permits; AND
- 6 FURTHER PROVIDING FOR OPERATION BY PERSONS UNDER AGE SIXTEEN.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The definition of "snowmobile" in section 7702 of
- 10 Title 75 of the Pennsylvania Consolidated Statutes is amended
- 11 and the section is amended by adding definitions to read:
- 12 § 7702. Definitions.
- 13 The following words and phrases when used in this chapter
- 14 shall have, unless the context clearly indicates otherwise, the
- 15 meanings given to them in this section:
- 16 * * *
- 17 "Snowmobile." An engine-driven vehicle which is all of the

- 1 following:
- 2 (1) Is designed to travel over snow or ice.
- 3 (2) Has an endless belt track or tracks.
- 4 (3) Is steered by a ski or skis.
- 5 (4) Has an overall width of 48 inches or less.
- 6 The term does not include a farm tractor, construction
- 7 equipment, military vehicle, vehicle with inflatable tires or
- 8 machinery used strictly for the grooming of snowmobile trails.
- 9 The term includes vintage snowmobiles.
- 10 * * *
- 11 <u>"Vintage snowmobile." A snowmobile that is at least 25 years</u>
- 12 <u>old and is not operated in this Commonwealth except at vintage</u>
- 13 <u>snowmobile events.</u>
- 14 "Vintage snowmobile event." An organized ride or rally for
- 15 <u>owners and operators of vintage snowmobiles, for which a permit</u>
- 16 <u>has been issued under section 7718(a) (relating to vintage</u>
- 17 snowmobile permits) and carried and exhibited in compliance with
- 18 section 7718(b) and which meets all of the following conditions:
- 19 (1) It is open to the public and publicized as such.
- 20 (2) It takes place on a specified date or dates and
- 21 within a specified start and end time.
- 22 (3) It takes place on a designated trail with a
- 23 specified beginning and end point.
- Section 2. Section 7706(a)(1) of Title 75 is amended to
- 25 read:
- 26 § 7706. Restricted account.
- 27 (a) Deposit and use of moneys.--
- 28 (1) The department shall deposit the following into a
- 29 restricted account, which is hereby established:
- 30 (i) all moneys received from the registration of and

- 1 issuance of certificates of title for snowmobiles and
- 2 ATV's and from the issuance of vintage snowmobile
- 3 permits;
- 4 (ii) all revenue from the sale of any publications
- or services relating to snowmobiles and ATV's; and
- 6 (iii) all fines, penalties, fees and costs assessed
- 7 and collected as a result of enforcement activities
- 8 conducted by the department's law enforcement personnel
- 9 under this chapter.

- Section 4. Section 7711.1(f) of Title 75 is amended by
- 17 adding a paragraph to read:
- 18 § 7711.1. Registration of snowmobile or ATV.

- 20 (f) Exemptions from registration. -- Subsection (a) does not
- 21 apply if:
- 22 * * *
- 23 (5) The snowmobile is a vintage snowmobile.
- 24 Section 5. Sections 7712.1(q), 7715.2(a) and 7716 of Title
- 25 75 are amended to read:
- 26 § 7712.1. Certificate of title for snowmobile or ATV.
- 27 * * *
- 28 (g) Registration without certificate of title prohibited. --
- 29 Except as provided in subsection (b), the department shall not
- 30 issue a registration certificate or limited registration

- 1 certificate for a snowmobile or ATV or a vintage snowmobile
- 2 permit for a vintage snowmobile unless a certificate of title
- 3 has been issued by the department to the owner or an application
- 4 for a certificate of title has been delivered by the owner to
- 5 the department.

- 7 § 7715.2. Fees.
- 8 (a) Fees.--Except as provided in subsection (b), the
- 9 department shall collect the following fees:
- 10 (1) Certificate of title, \$22.50.
- 11 (2) Expiration sticker, \$20.
- 12 (2.1) Vintage snowmobile permit, \$20.
- 13 (3) Dealer registration, \$25.
- 14 (4) Replacement, due to loss or damage, of registration
- 15 certificate, limited registration certificate, registration
- decal, registration plate [or] expiration sticker or vintage
- 17 snowmobile permit, \$5.
- 18 (5) Transfer of registration pursuant to section 7711.1
- 19 (relating to registration of snowmobile or ATV), \$5.
- 20 (6) Recording the name of a secured party on a
- 21 certificate of title, \$5.

- 23 § 7716. Records.
- 24 The department shall maintain a record, which shall be made
- 25 available to all enforcement agencies, of:
- 26 (1) The registration number for each snowmobile and ATV
- for which a registration certificate or limited registration
- 28 certificate is issued.
- 29 (2) The name and address of the owner of each snowmobile
- 30 and ATV for which a registration certificate or limited

- 1 registration certificate is issued.
- 2 (3) The permit number for each vintage snowmobile for
- 3 which a vintage snowmobile permit is issued.
- 4 (4) The name and address of the owner of each vintage
- 5 <u>snowmobile for which a vintage snowmobile permit is issued.</u>
- 6 Section 6. Title 75 is amended by adding a section to read:
- 7 § 7718. Vintage snowmobile permits.
- 8 (a) Issuance of permits. -- Upon receipt of an application
- 9 upon a form prescribed and furnished by the department which
- 10 shall contain information required by the department and which
- 11 shall be accompanied by the required fee and any other
- 12 information the department shall require, the department shall
- 13 <u>issue to an owner of a vintage snowmobile a vintage snowmobile</u>
- 14 permit containing a permit number.
- 15 (b) Carrying and exhibiting permit. -- Every permit shall, at
- 16 <u>all times while the vehicle is being operated, be in the</u>
- 17 possession of the person driving or in control of the vehicle or
- 18 carried in the vehicle and shall be exhibited on demand of a
- 19 police officer or authorized department employee.
- 20 (c) Not transferable. -- A vintage snowmobile permit is not
- 21 transferable to a successor owner or to another vehicle. On
- 22 transfer of ownership of a vintage snowmobile for which a
- 23 <u>vintage snowmobile permit has been issued, the permit shall</u>
- 24 become invalid.
- 25 (d) Suspension or revocation. -- The department may suspend or
- 26 revoke a vintage snowmobile permit upon conviction of the holder
- 27 of an offense under this chapter. A suspended or revoked vintage
- 28 snowmobile permit is invalid.
- 29 SECTION 7. SECTION 7725(H) OF TITLE 75 IS AMENDED TO READ:
- 30 § 7725. OPERATION BY PERSONS UNDER AGE SIXTEEN.

- 2 (H) SNOWMOBILE AND ATV SAFETY PROGRAM. -- THE DEPARTMENT SHALL
- 3 IMPLEMENT A COMPREHENSIVE SNOWMOBILE AND ATV INFORMATION, SAFETY
- 4 EDUCATION AND TRAINING PROGRAM WHICH SHALL INCLUDE THE
- 5 PREPARATION AND DISSEMINATION OF INFORMATION AND SAFETY ADVICE
- 6 TO THE PUBLIC AND TRAINING OF OPERATORS. THE PROGRAM SHALL
- 7 PROVIDE FOR THE TRAINING OF YOUTHFUL OPERATORS AND OTHERS WHO
- 8 <u>WISH TO RECEIVE TRAINING. IT SHALL ALSO PROVIDE</u> FOR THE ISSUANCE
- 9 OF SNOWMOBILE OR ATV SAFETY CERTIFICATES TO THOSE WHO
- 10 SUCCESSFULLY COMPLETE THE TRAINING PROVIDED UNDER THE PROGRAM.

- 12 Section 7 8. This act shall take effect in 60 120 days.
