- 8 hereby enacts as follows:
- 9 Section 1. The title of the act of May 16, 2008 (P.L.152,

- 3 Section 2. Section 1 of the act is amended to read:

- 5 (a) Designation. -- The newly replaced bridge on Dillerville
- 6 Road in the City of Lancaster, Lancaster County, State Bridge
- 7 No. 36-4009-0030-0000, is designated and shall be known as the
- 8 Captain Edward Anthony Davis Memorial Bridge.
- 9 (b) Signs.--The Department of Transportation shall erect and
- 10 maintain appropriate signs which shall display the name of the
- 11 bridge designated in subsection (a) at each end of the bridge.
- 12 Section 3. This act shall take effect in 60 days.
