- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated 2 Statutes, further providing for width of vehicles.

- 13 Special vehicles. -- THE FOLLOWING PARAGRAPHS DETERMINE
- WIDTHS FOR SPECIAL VEHICLES, WITH EACH PARAGRAPH SPECIFICALLY 14

1	CONTROLLING ITS OWN SUBJECT MATTER IN THE EVENT OF A CONFLICT
2	WITH ANOTHER PARAGRAPH:
3	(1) Any implement of husbandry or vehicle loaded with
4	[vegetable produce or forage] crops or nutrients and not
5	exceeding [11] $\underline{12}$ feet in width may be driven, hauled or
6	towed between sunrise and sunset on highways other than
7	freeways.
8	(2) Any implement of husbandry not exceeding 14 feet 6
9	inches in width may be driven, hauled or towed between
10	sunrise and sunset on highways other than freeways:
11	(i) Between parts of one farm owned or operated by
12	the owner of the implement of husbandry.
13	(ii) Between farms owned or operated by the owner of
14	the implement of husbandry located not more than 50 miles
15	apart.
16	(iii) Between:
17	(A) farms; or
18	(B) a farm owned or operated by a farmer and a
19	place of business of a mechanic or dealer in
20	<pre>implements of husbandry;</pre>
21	located not more than 150 miles away for the purpose of
22	buying, selling, trading, loaning and leasing,
23	demonstrating, repairing or servicing the implement of
24	husbandry.
25	(3) Special mobile equipment not exceeding nine feet two
26	inches in width may be driven, hauled or towed between
27	sunrise and sunset on highways other than freeways.
28	(4) The department may regulate the operation of special
29	vehicles subject to this subsection which regulations may

(5) An implement of husbandry or vehicle used			
[exclusively for highly perishable crops for processing] for			
<pre>crops or nutrients and not exceeding 14 feet 6 inches in</pre>			
width may be operated on highways other than freeways between			
sunset and sunrise [only during the period of May 20 to			
October 15]. The implement or vehicle, when used at this-			
time, shall have two rotating yellow beacons and vehicular			
hazard signal lamps operating.

THIS TIME, SHALL HAVE [TWO ROTATING YELLOW BEACONS] AND
[VEHICULAR] OPERATE AT LEAST ONE FLASHING OR REVOLVING YELLOW
LIGHT OR STROBE LIGHT, WHICH SHALL BE MOUNTED TO PROVIDE
VISIBILITY TO VEHICLES APPROACHING FROM ANY DIRECTION, 360DEGREE VISIBILITY, REGARDLESS OF THE METHOD OF MOUNTING, AND
HAZARD [SIGNAL LAMPS OPERATING] SIGNALS.

(7) As used in this section, the following words and phrases shall have the meanings given to them in this subsection:

"Crop." The term includes, but is not limited to:

- (i) Field crops, including corn, wheat, oats, rye, barley, hay, potatoes and dry beans.
- 29 <u>(ii) Fruits, including apples, peaches, grapes,</u>
- 30 <u>cherries and berries.</u>

1	(iii) Vegetables, including tomatoes, snap beans,
2	cabbage, carrots, beets, onions and mushrooms.
3	"Nutrient." The term includes, but is not limited to:
4	(i) A substance or recognized plant nutrient,
5	element or compound that is used or sold for its plant
6	nutritive content or its claimed nutritive value.
7	(ii) Livestock and poultry manures and their
8	byproducts, compost used as fertilizer, commercially
9	manufactured chemical fertilizers, biosolids or
10	combinations of commercially manufactured chemical
11	biosolids.
