- WHEREAS, On February 11, 1911, Jozef Murgas, pastor of the
- 5 Sacred Heart of Jesus Slovak Church in Wilkes-Barre,
- 6 Pennsylvania, in the Diocese of Scranton, founded the Slovak
- 7 Catholic Federation; and
- 8 WHEREAS, The following goals guide the pastoral work and
- 9 ministry of the Slovak Catholic Federation:
- 10 (1) Promote the Slovak Catholic heritage and its
- 11 awareness among Slovak Catholics in the United States.
- 12 (2) Continue the apostolic tradition of Saints Cyril and
- 13 Methodius by promoting the proclamation of the Gospel through
- 14 the works of faith, charity, education and pilgrimage.
- 15 (3) Establish and maintain the bonds of fraternal

- 1 cooperation among Slovak Catholic societies and Slovak
- 2 Catholics in the United States, and to foster such bonds by
- 3 the promotion and sponsorship of religious and social
- 4 activities.
- 5 (4) Support vocations to the ordained ministry and
- 6 religious life both in the United States and Slovakia.
- 7 (5) Assist the Catholic Church in the Slovak Republic,
- 8 primarily by supporting the Pontifical College of Saints
- 9 Cyril and Methodius in Rome, Italy, and by rendering
- 10 financial support for the formation of both for the clergy
- 11 and those religious.
- 12 (6) Maintain structures that foster gatherings of Slovak
- 13 Catholics in various areas of the United States;

- 19 C. Bambera, D.D., J.C.L., Bishop of Scranton, presiding along
- 20 with the Most Rev. Joseph C. Adamec, D.D., S.T.L., Episcopal
- 21 Moderator of the Slovak Catholic Federation and the Rev. Philip
- 22 A. Altavilla, V.E., serving as homilist; therefore be it
- 23 RESOLVED, That the House of Representatives designate May 15,
- 24 2011, as "Slovak Catholic Federation Day" in Pennsylvania; and
