## AN ACT

- Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An act to consolidate, editorially revise, and codify the public welfare laws of the Commonwealth," in public assistance, further providing for definitions; and, in public assistance, providing for mileage reimbursement for individuals receiving methadone treatment.

  The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:
- 9 Section 1. Section 402 of the act of June 13, 1967 (P.L.31,
- 10 No.21), known as the Public Welfare Code, is amended by adding
- 11 definitions to read:
- 12 Section 402. Definitions.--As used in this article, unless
- 13 the content clearly indicates otherwise:
- 14 \* \* \*
- 15 "Medical assistance transportation program" means the program
- 16 <u>funded in part by the Department of Public Welfare that provides</u>
- 17 transportation to medical services for medical assistance
- 18 patients who have no other transportation available to them.
- 19 "Methadone" means a synthetic opioid agonist which binds with

- 1 opioid receptors in the brain to initiate drug actions that
- 2 mimic the effects of opiates.
- 3 "Narcotic treatment program" means a program for chronic drug
- 4 <u>users that either administers or dispenses agents under a</u>
- 5 narcotic treatment physician's order for detoxification or
- 6 maintenance purposes, or provides a comprehensive range of
- 7 <u>medical and rehabilitative services to alleviate adverse</u>
- 8 medical, psychological or physical effects incident to an
- 9 addiction to narcotics, or both.

- 11 Section 2. The act is amended by adding a section to read:
- 12 Section 443.11. Mileage Reimbursement for Individuals
- 13 Receiving Methadone Treatment. -- (a) An individual receiving
- 14 methadone treatment by a licensed provider, pursuant to a
- 15 narcotic treatment program, shall be eligible for mileage
- 16 <u>reimbursement only if the treatment is received at the treatment</u>
- 17 program closest to the individual's residence based on a one-way
- 18 trip calculation.
- 19 (b) The department may develop an exceptions process based
- 20 on medical emergency and availability of closest provider.
- 21 (c) County medical assistance transportation programs in
- 22 consultation with the department shall develop procedures for
- 23 the prevention, detection and reporting of suspected fraud and
- 24 abuse relating to the reimbursement of mileage for methadone
- 25 treatment.
- 26 Section 3. This act shall take effect in 30 days.
