AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the 4 laws relating thereto," in district and assistant 5 superintendents, further providing for eligibility; and 6 making editorial changes. 7 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Article X heading and section 1001 of the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code 11 of 1949, amended January 14, 1970 (1969 P.L.468, No.192), are 12 13 amended to read: 14 ARTICLE X. 15 DISTRICT SUPERINTENDENTS AND ASSISTANT DISTRICT SUPERINTENDENTS. 16 Section 1001. Purpose. -- For the superintendence and 17 supervision of the public schools of this Commonwealth, there 18 shall be elected or appointed, in the manner herein provided, 19 district superintendents, and assistant district

- 3 Section 1003. Eligibility.--[No] (a) Except as otherwise
- 4 provided in subsection (b), no person shall be eligible for
- 5 election or appointment as a district[,] <u>superintendent</u> or
- 6 assistant district superintendent, unless--
- 7 (1) He holds a diploma from a college or other institution
- 8 approved by the Department of Education;
- 9 (2) He has had six (6) years' successful teaching
- 10 experience, not less than three of which shall have been in a
- 11 supervisory or administrative capacity;
- 12 (3) He has completed in a college or university a graduate
- 13 program in education approved by the Department of Education
- 14 that includes the Pennsylvania school leadership standards under
- 15 section 1217. Completion of the program shall not be subject to
- 16 waiver under section 1714-B unless the candidate provides to the
- 17 Secretary of Education evidence that the candidate has
- 18 successfully completed an equivalent leadership development
- 19 program that addresses the school leadership standards under
- 20 section 1217.
- 21 (4) Provided that in school districts of the first class,
- 22 five (5) years of administrative experience at the level of
- 23 assistant, associate or deputy superintendent, may be
- 24 substituted for prescribed graduate administrative courses, and
- 25 which shall be the responsibility of the Secretary of Education
- 26 to review these equivalences to conform with State board
- 27 regulations.

- 7 (C) A PERSON ELECTED OR APPOINTED AS A DISTRICT
- 8 <u>SUPERINTENDENT OR ASSISTANT DISTRICT SUPERINTENDENT UNDER</u>
- 9 <u>SUBSECTION</u> (B) <u>SHALL SUCCESSFULLY COMPLETE A LEADERSHIP</u>
- 10 DEVELOPMENT PROGRAM THAT MEETS THE PENNSYLVANIA SCHOOL
- 11 <u>LEADERSHIP STANDARDS UNDER SECTION 1217.</u>
- 12 Section 3. This act shall take effect in 60 days.
