9 MISCELLANEOUS PROVISIONS

- 10 Section 501. Transfers prohibited. -- There is no authority
- 11 for the State Treasurer, the Secretary of the Budget, the
- 12 Secretary of Revenue or the Pennsylvania Gaming Control Board to
- 13 transfer any money within or between the appropriations in Part
- 14 III.
- 15 Section 502. Effective date. -- This act shall take effect
- 16 July 1, 2011, or immediately, whichever is later.
