## AN ACT

1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated  
2 Statutes, ~~providing for biennial registration of certain~~ <--

13 ~~The department may establish a system for renewing the~~  
14 ~~vehicle registration of passenger cars, Class 1 trucks and Class~~  
15 ~~2 trucks on a biennial basis to owners and lessees of the~~  
16 ~~vehicles and may promulgate rules and regulations to implement~~  
17 ~~the system.~~

18 ~~Section 2. Sections 1911(a) and 1912 of Title 75 are amended~~

~~§ 1911. Annual and biennial registration fees.~~

~~(a) General rule. An annual or optional biennial fee for the registration of vehicles as provided in Chapter 13 (relating to the registration of vehicles) shall be charged by the department as provided in this title.~~

~~§ 1912. Passenger cars.~~

~~(a) General rule. The annual fee for registration of a passenger car shall be \$36.~~

~~(b) Optional biennial registration. A vehicle may be registered for a period of two years upon payment by the registrant of the applicable fee of \$72.~~

~~Section 3. Section 1916 of Title 75 is amended by adding a subsection to read:~~

~~§ 1916. Trucks and truck tractors.~~

~~(c) Optional biennial registration. A vehicle designated Class 1 or Class 2 under this section may be registered for a period of two years upon payment by the registrant of the applicable fee of \$117 for Class 1 and \$162 for Class 2.~~

~~Section 4. This act shall take effect in 180 days.~~

~~(G) OPTIONAL BIENNIAL REGISTRATION.--UPON APPLICATION ON A FORM PRESCRIBED BY THE DEPARTMENT, THE OWNER OR LESSEE OF A MOTOR VEHICLE, EXCEPT THOSE REGISTERED UNDER THE INTERNATIONAL REGISTRATION PLAN AND THOSE WITH A SEASONAL REGISTRATION OR A~~

1 CIRCUS OR CARNIVAL PLATE, MAY ELECT TO PAY ANNUAL REGISTRATION  
2 FEES FOR A TWO-YEAR PERIOD.

11 (A) GENERAL RULE.--[AN ANNUAL] A FEE FOR THE REGISTRATION OF  
12 VEHICLES AS PROVIDED IN CHAPTER 13 (RELATING TO THE REGISTRATION  
13 OF VEHICLES) SHALL BE CHARGED BY THE DEPARTMENT AS PROVIDED IN  
14 THIS TITLE.
