AN ACT

- 1 Requiring certain large mass transit agencies to purchase buses 2 that meet certain criteria within a specific implementation
- 3 schedule; and providing for the powers and duties of the
- 4 Department of Transportation.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Public
- 9 Transportation and Natural Gas Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Bus." A motor vehicle designed for carrying 15 or more
- 15 passengers, exclusive of the driver, and used for the
- 16 transportation of persons for compensation.
- 17 "Department." The Department of Transportation of the

- 1 Commonwealth.
- 2 "Large mass transit agency." A mass transit agency in this
- 3 Commonwealth that:
- 4 (1) Exceeds 245,000 revenue vehicle hours for two
- 5 consecutive years as defined in 74 Pa.C.S. § 1503 (relating
- 6 to definitions).
- 7 (2) Provides regularly scheduled transportation that is
- 8 available to the general public and is provided according to
- 9 published schedules along designated published routes with
- specified stopping points for the taking on and discharging
- of passengers, including public buses. The term does not
- include a commuter rail system, exclusive ride taxi service,
- charter or sightseeing service, nonpublic transportation,
- school bus or limousine service.
- "Natural gas." Gas issued from the Earth's crust through
- 16 natural openings or bored wells and that is typically a
- 17 combustible mixture of methane and other hydrocarbons used
- 18 chiefly as a fuel and raw material. The term includes the
- 19 compressed form and liquefied form of natural gas.
- 20 Section 3. New bus requirements.
- 21 (a) General rule. -- When purchasing a new bus, a large mass
- 22 transit agency must purchase a bus that:
- 23 (1) Is manufactured in the United States of America.
- 24 (2) Uses natural gas as its fuel source.
- 25 (3) Complies with the implementation schedule stated in
- 26 subsection (b).
- 27 (b) Implementation schedule. -- New bus purchases by a large
- 28 mass transit agency under subsection (a) shall be made according
- 29 to the following schedule:
- 30 (1) In calendar years 2013 through 2017, inclusive, no

- less than 25% of all new buses purchased shall use natural
- 2 gas as their fuel source.
- 3 (2) In calendar years 2018 through 2022, inclusive, no
- 4 less than 50% of all new buses purchased shall use natural
- 5 gas as their fuel source.
- 6 (3) In calendar years 2023 through 2027, inclusive, no
- 7 less than 75% of all new buses purchased shall use natural
- 8 gas as their fuel source.
- 9 (4) In calendar year 2028 and each calendar year
- 10 thereafter, 100% of all new buses purchased shall use natural
- gas as their fuel source.
- 12 Section 4. Enforcement.
- 13 The department shall investigate compliance with and enforce
- 14 the provisions of this act.
- 15 Section 5. Regulations.
- 16 The department shall promulgate rules and regulations as
- 17 necessary to implement and administer the provisions of this
- 18 act.
- 19 Section 6. Effective date.
- This act shall take effect in 60 days.
