14 THE FOLLOWING WORDS AND PHRASES WHEN USED IN THIS SUBCHAPTER 15 SHALL HAVE, UNLESS THE CONTEXT CLEARLY INDICATES OTHERWISE, THE 16 MEANINGS GIVEN TO THEM IN THIS SECTION:

18 "PRIMARY JURISDICTION." THE GEOGRAPHICAL AREA WITHIN THE 19 TERRITORIAL LIMITS OF A MUNICIPALITY OR ANY LAWFUL COMBINATION 20 OF MUNICIPALITIES WHICH EMPLOYS A MUNICIPAL POLICE OFFICER AND, 21 IN THE CASE OF A COUNTY OF THE THIRD CLASS THAT HAS ESTABLISHED 22 A COUNTY PARK POLICE FORCE IN ACCORDANCE WITH THE PROVISIONS OF 23 SECTION 2511 OF THE ACT OF AUGUST 9, 1955 (P.L.323, NO.130), 24 KNOWN AS THE COUNTY CODE, THE GEOGRAPHICAL AREA DESIGNATED BY 25 ORDINANCE OF ITS BOARD OF COUNTY COMMISSIONERS AS THE 26 JURISDICTIONAL AREA FOR THE COUNTY PARK POLICE.

1 § 2162. Definitions.

The following words and phrases when used in this subchapter shall have the meanings given to them in this section unless the context clearly indicates otherwise:

6 "Police department." Any of the following:

7 (1) A public agency of a political subdivision having 8 general police powers and charged with making arrests in 9 connection with the enforcement of the criminal or traffic 10 laws. This paragraph includes the sheriff's office in a 11 county of the second class.

12 (2) A campus police or university police department, as 13 used in section 2416 of the act of April 9, 1929 (P.L.177, 14 No.175), known as The Administrative Code of 1929, certified 15 by the Office of Attorney General as a criminal justice 16 agency under the definition of "criminal justice agency" in 17 18 Pa.C.S. § 9102 (relating to definitions). This paragraph 18 does not include a campus police or university police 19 department of the State System of Higher Education and its 20 member institutions.

(3) A railroad or street railway police department
formed with officers commissioned under 22 Pa.C.S. Ch. 33
(relating to railroad and street railway police) or any prior
statute providing for such commissioning.

(i) A police department of a county, city, borough,

<u>(a) Second class counties.--</u>Counties of the second class
 shall be liable for costs incurred for the certification of
 deputy sheriffs. The costs shall not exceed the sum per police
 officer assessed against municipalities.
