AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
 Statutes, further providing for special registration plates
 generally and for personal registration plates; providing for
 Appalachian Trail organization registration plates; and
 making editorial changes.

 The General Assembly of the Commonwealth of Pennsylvania
 hereby enacts as follows:

 Section 1. Sections 1333(b.1) and 1341 of Title 75 of the
 Pennsylvania Consolidated Statutes are amended to read:
- 10 § 1333. Lost, stolen, damaged or illegible registration plate.
- 11 * * *
- 12 (b.1) Illegible registration plate. -- The department may
- 13 reissue a registration plate upon request by a registrant when
- 14 it is determined by an authorized representative of the
- 15 department or law enforcement that the registration plate is
- 16 illegible from a reasonable distance. The department may select
- 17 the style of the reissued registration plate and, except in the
- 18 case of personal registration plates issued under section 1341

- 1 (relating to special registration plates [generally]), the
- 2 registration plate number.
- 3 * * *
- 4 § 1341. Special registration plates [generally].
- 5 <u>(a) General rule.--</u>Upon request by the applicant, the
- 6 department may issue registration plates consisting of any
- 7 combination of numbers, letters or numbers and letters. [These
- 8 special plates may be issued for special groups or for special
- 9 purposes and bear an appropriate designation. Special groups may
- 10 charge a fee for authorization to request a registration plate
- 11 bearing the name of the group.] They shall have the same force
- 12 and effect as regular registration plates. The department may
- 13 refuse any combination of letters and numbers for cause and
- 14 shall adopt reasonable rules and regulations for the issuance of
- 15 the plates and for carrying out the provisions of this section.
- 16 The applicant shall comply with all laws and regulations
- 17 pertaining to registration including the payment of any
- 18 additional fees.
- (b) Personal registration plates. -- Upon request by the
- 20 applicant, the department is authorized to issue personal
- 21 registration plates. The department is authorized to reissue a
- 22 combination of numbers or letters for a personal plate if the
- 23 department records reveal that no activity, such as renewal or
- 24 transfer of the personal registration plate, has occurred for a
- 25 period of five or more consecutive years and provided that the
- 26 personal registration plate was never reported as lost or
- 27 stolen. Whenever the department reissues an inactive personal
- 28 plate, the department may purge its records of all references to
- 29 the previous owners of that personal plate. The department
- 30 shall, however, note upon its records the reissuance of the

- 1 personal plate and to whom the plate was issued. [The special] \underline{A}
- 2 <u>personal</u> registration plate may be used only on a passenger car
- 3 [or], motorcycle, truck with a registered gross weight of not
- 4 more than [10,000] <u>14,000</u> pounds, trailer or motor home.
- 5 (c) Organization registration plates. -- Upon request by the
- 6 applicant, the department is authorized to issue organization
- 7 <u>registration plates. Organization registration plates may be</u>
- 8 <u>issued for special groups or for special purposes and bear an</u>
- 9 appropriate designation. Special groups may charge a fee for
- 10 authorization to request a registration plate bearing the name
- 11 of the group. If the vehicle is licensed to a business that is
- 12 not a member of the special group, the department shall issue
- 13 the plate as long as the business owner or officer making
- 14 application is a member of that group. An organization
- 15 registration plate may be used only on a passenger car or truck
- 16 with a registered gross weight of not more than 14,000 pounds or
- 17 a motor home.
- 18 Section 2. Title 75 is amended by adding sections to read:
- 19 § 1341.1 Personal organization registration plates.
- 20 (a) General rule. -- The department may, upon application of
- 21 any person and upon payment of the additional fee under this
- 22 section, issue a personal organization registration plate to
- 23 <u>applicants for special registration plates authorized in this</u>
- 24 chapter.
- 25 (b) Additional fee.--
- 26 (1) The department shall collect an additional fee of up
- 27 <u>to \$300 for any personal special registration plate or</u>
- 28 personal organization registration plates issued under
- 29 <u>subsection (a).</u>
- 30 (2) For any personal plate issued under sections 1338

- 1 (relating to person with disability plate and placard) and
- 2 1342 (relating to veteran plates and placard), the department
- 3 <u>shall collect only an additional fee of \$50.</u>
- 4 § 1352.1. Appalachian Trail organization registration plates.
- 5 The department, in consultation with the Appalachian Trail
- 6 Conservancy, shall design a special Appalachian Trail
- 7 organization registration plate. The plate, at a minimum, shall
- 8 contain the image of a hiker and the Appalachian Trail
- 9 Conservancy logo and distinctive coloring. Upon application of
- 10 any person, accompanied by the appropriate fee, the department
- 11 <u>shall issue the plate for a passenger car or truck with a</u>
- 12 registered gross weight of not more than 14,000 pounds or a
- 13 motor home.
- 14 Section 3. Sections 1786(h)(2) and 1931 of Title 75 are
- 15 amended to read:
- 16 § 1786. Required financial responsibility.
- 17 * * *
- 18 (h) Reinstatement of voluntarily surrendered registration
- 19 plate and card.--
- 20 * * *
- 21 (2) Any registration plate issued under sections 1340
- 22 (relating to antique and classic plates) and 1341 (relating
- 23 to [personal plate] special registration plates) shall be
- 24 returned by the department to the owner of the motor vehicle
- upon receipt of proof of financial responsibility.
- 26 * * *
- 27 § 1931. [Personal] <u>Special</u> registration plates.
- The fee for issuance of a [personal] special registration
- 29 plate shall be \$20 which shall be in addition to the annual
- 30 registration fee. Only one payment of the issuance fee shall be

- 1 charged for each [personal] <u>special</u> registration issued or
- 2 replaced.
- 3 Section 4. This act shall take effect in 120 days.
