1 2 3	Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, further providing for drug-free school zones.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. Section 6317(a) of Title 18 of the Pennsylvania
7	Consolidated Statutes is amended to read:
8	§ 6317. Drug-free school zones.
9	(a) General ruleA person 18 years of age or older who is
10	convicted in any court of this Commonwealth of a violation of
11	section 13(a)(14) or (30) of the act of April 14, 1972 (P.L.233,
12	No.64), known as The Controlled Substance, Drug, Device and
13	Cosmetic Act, shall, if the delivery or possession with intent
14	to deliver of the controlled substance occurred within 1,000
15	feet of the real property on which is located a public, private
16	or parochial school or a college or university or within [250]

1 <u>1,000</u> feet of the real property on which is located a recreation 2 center or playground or on a school bus, be sentenced to a 3 minimum sentence of at least two years of total confinement, 4 notwithstanding any other provision of this title, The 5 Controlled Substance, Drug, Device and Cosmetic Act or other 6 statute to the contrary. The maximum term of imprisonment shall 7 be four years for any offense:

(1) subject to this section; and

9 (2) for which The Controlled Substance, Drug, Device and 10 Cosmetic Act provides for a maximum term of imprisonment of 11 less than four years.

12 If the sentencing court finds that the delivery or possession 13 with intent to deliver was to an individual under 18 years of 14 age, then this section shall not be applicable and the offense 15 shall be subject to section 6314 (relating to sentencing and 16 penalties for trafficking drugs to minors).
