2 (1) A learner's permit shall be valid for a period of 3 one year after date of issue, or until the holder of the permit has failed the examination as authorized in section 4 5 1508 (relating to examination of applicant for driver's 6 license) three times within the one-year period. 7 (2) A person may reapply for a motorcycle learner's permit no more frequently than three times in a five-year 8 9 period from when the person first applies.
