- 3 (1) Provide a statement on youth suicide prevention and
- 4 <u>awareness and the protocols for administering youth suicide</u>

- 7 entity to implement a procedure that identifies:
- 8 <u>(i) Methods of prevention, including protocols for early</u>
- 9 identification and referral of students at risk of suicide.
- 10 (ii) Methods of intervention, including protocols that
- 11 <u>address an emotional or mental health safety plan for students</u>
- 12 <u>identified as being at increased risk of suicide.</u>
- 13 <u>(iii) Methods of postvention, including protocols for</u>
- 14 <u>responding to a student or staff suicide or suicide attempt.</u>
- 15 <u>(iv) Reporting procedures.</u>
- 16 <u>(v) Current contact information for and resources available</u>
- 17 on suicide awareness and prevention programs.
- 18 (b) A school entity:
- 19 (1) Shall inform all school entity employes of the policy
- 20 and make available to them youth suicide awareness and
- 21 prevention education, materials and resources based on the
- 22 policy.
- 23 (2) Shall, beginning with the 2015 2016 school year, submit
- 24 the professional development plan to the secretary for approval
- 25 pursuant to section 1205.1 that includes four (4) hours of
- 26 <u>training in youth suicide awareness and prevention every five</u>
- 27 (5) years for professional educators in school buildings serving
- 28 students in grade six (6), seven (7), eight (8), nine (9), ten
- 29 (10), eleven (11) or twelve (12). Training under this subsection
- 30 may be used to satisfy a professional educator's continuing

- 1 professional education requirement under section 1205.2.
- 2 (3) May provide youth suicide awareness and prevention
- 3 education to other staff, including contractors and nonteaching-
- 4 staff.
- 5 (4) Shall incorporate youth suicide awareness and prevention
- 6 <u>education that is based on the policy and is age appropriate</u>
- 7 into the curriculum. A school entity may utilize the youth
- 8 <u>suicide awareness and prevention education, materials and</u>
- 9 resources from a list of approved resources maintained by the
- 10 Department of Education.
- 11 <u>(c) The Department of Education shall maintain a list of</u>
- 12 approved resources and training materials and age appropriate
- 13 youth suicide awareness and prevention education, materials and
- 14 <u>resources as provided in subsection (b) on its publicly</u>
- 15 accessible Internet website. The Department of Education shall
- 16 work in conjunction with a youth suicide prevention organization
- 17 operating in this Commonwealth to determine which materials and
- 18 resources are most appropriate.

- 17 IDENTIFIED AS BEING AT INCREASED RISK OF SUICIDE.
- 18 (C) METHODS OF RESPONDING TO A SUICIDE OR SUICIDE ATTEMPT BY
- 19 A STUDENT OR EMPLOYE OF THE SCHOOL ENTITY.
- (D) REPORTING PROCEDURES.
- 21 (E) RECOMMENDED RESOURCES ON YOUTH SUICIDE AND YOUTH SUICIDE
- 22 AWARENESS AND PREVENTION PROGRAMS, INCLUDING CONTACT INFORMATION
- 23 FOR SUCH PROGRAMS.
- 24 (2) DEVELOP A MODEL YOUTH SUICIDE AWARENESS AND PREVENTION
