## AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain 2
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the 5
  - laws relating thereto," in terms and courses of study,
- providing for emergency lockdown drills. 6
- The General Assembly of the Commonwealth of Pennsylvania 7
- hereby enacts as follows: 8
- 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- as the Public School Code of 1949, is amended by adding a 10
- 11 section to read:
- 12 Section 1517.1. Emergency Lockdown Drills.--(a) In all
- elementary and secondary public schools emergency lockdown 13
- 14 drills shall be periodically conducted, not less than one a
- 15 month, by the teacher or teachers in charge, under rules and
- regulations to be promulgated by the district superintendent 16
- 17 having supervision over such schools. In the drills, the pupils
- 18 and teachers shall be instructed in, and made thoroughly
- familiar with, the steps that are to be taken in the event that

- 1 the school is put in a lockdown.
- 2 (b) District superintendents are hereby required to see that
- 3 the provisions of this section are faithfully carried out in the
- 4 schools over which they have charge.
- 5 (c) Any person who violates or fails to comply with the
- 6 provisions of this section commits a misdemeanor and shall, upon
- 7 conviction, be sentenced to pay a fine of not less than twenty-
- 8 five dollars (\$25) nor more than five hundred dollars (\$500), or
- 9 to imprisonment for not less than ten (10) days nor more than
- 10 sixty (60) days, or both.
- 11 (d) All schools using or contracting for school buses for
- 12 the transportation of school children shall conduct on school
- 13 grounds two emergency lockdown drills on buses during each
- 14 school year, the first to be conducted during the first week of
- 15 the first school term and the second during the month of March,
- 16 and at such other times as the chief school administrator may
- 17 require. Bus operators shall be provided with proper training
- 18 and instructions to enable them to carry out the provisions of
- 19 this subsection and may be required to attend classes and drills
- 20 <u>in connection therewith.</u>
- 21 (e) On or before the tenth day of April of each year, each
- 22 district superintendent shall certify to the Department of
- 23 Education that the emergency lockdown drills required under this
- 24 <u>section have been held.</u>
- 25 Section 2. This act shall take effect in 60 days.
