AN ACT

- Requiring certain health care practitioners to disseminate information relating to Down syndrome; and imposing duties on
- 3 the Department of Health.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Down Syndrome
- 8 Prenatal Education Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- "Department." The Department of Health of the Commonwealth.
- 14 "Health care practitioner." A health care practitioner that
- 15 provides prenatal or postnatal care or genetic counseling to
- 16 expectant or new parents.

- 1 Section 3. Dissemination of information on Down syndrome.
- 2 (a) Requirement. -- A health care practitioner that
- 3 administers, or causes to be administered, a test for Down
- 4 syndrome to an expectant or new parent shall, upon receiving a
- 5 test result that is positive for Down syndrome, provide the
- 6 expectant or new parent with educational information made
- 7 available by the department under section 4.
- 8 (b) Compliance.--Delivery of information prepared by the
- 9 department in accordance with section 4 at the time genetic
- 10 results or diagnostic conclusions are provided shall constitute
- 11 compliance with this section.
- 12 Section 4. Informational publications by department.
- 13 (a) General rule. -- The department shall make the following
- 14 available to health care practitioners:
- 15 (1) Up-to-date, evidence-based, printed information
- about Down syndrome that has been reviewed by medical experts
- and national Down syndrome organizations. The information
- 18 provided shall include the following:
- 19 (i) Physical, developmental, educational and
- 20 psychosocial outcomes.
- 21 (ii) Life expectancy.
- 22 (iii) Clinical course.
- 23 (iv) Intellectual and functional development.
- 24 (v) Treatment options.
- 25 (2) Contact information regarding First Call programs
- and support services, including the following:
- 27 (i) Information hotlines specific to Down syndrome.
- 28 (ii) Relevant resource centers or clearinghouses.
- 29 (iii) National and local Down syndrome
- 30 organizations, such as:

- 1 (A) The Jerome Lejeune Foundation USA.
- 2 (B) Parent to Parent of Pennsylvania.
- 3 (C) Pennsylvania Early Intervention.
- 4 (D) Other relevant education and support
- 5 programs.
- 6 (b) Additional dissemination. -- The department shall post the
- 7 information under subsection (a) on its publicly accessible
- 8 Internet website.
- 9 (c) Form. -- The information provided under this section shall
- 10 be culturally and linguistically appropriate for the intended
- 11 recipients of the information.
- 12 Section 5. Effective date.
- 13 This act shall take effect in 60 days.
