AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," prohibiting smoking at bus stops.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 9 as the Public School Code of 1949, is amended by adding a
- 10 section to read:
- 11 Section 1368. Smoking Prohibited. -- (a) A student of a
- 12 public school, private school or charter school may not smoke
- 13 within twenty-five (25) feet of a school bus stop for a time
- 14 period of thirty (30) minutes before the bus is scheduled to
- 15 <u>arrive to pick up a student until ten minutes after the school</u>
- 16 bus leaves after dropping off a student. The determination of
- 17 <u>time shall be determined as follows:</u>
- 18 (1) When the bus is scheduled to pick up students in the
- 19 morning, this section shall use the time of day in the current

- 1 prevailing time zone based upon the set time for the scheduled
- 2 bus stop as published or scheduled by the school district or the
- 3 <u>school district's busing contractor.</u>
- 4 (2) When the bus is scheduled to drop off students, this
- 5 <u>section shall use the time of day in the current prevailing time</u>
- 6 zone when the bus actually drops off the students at the bus
- 7 stop after the end of the school day.
- 8 (3) In the event of a delayed opening for the school, the
- 9 extra time delay shall be added to the regularly scheduled pick
- 10 up time as indicated in paragraph (1).
- 11 (b) The prohibition under subsection (a) shall be enforced
- 12 <u>as follows:</u>
- 13 (1) The prohibition shall include only the outdoor area
- 14 within twenty-five (25) feet of the bus stop.
- 15 (2) If the bus stop is a public stop also used by public
- 16 transportation, the prohibition shall apply only to the
- 17 students.
- 18 (3) If the bus stop is on a corner, the twenty-five (25)
- 19 foot radius shall be calculated from the side of the corner
- 20 where the students congregate to wait for the bus.
- 21 (4) If the bus stop is at a residence, the twenty-five (25)
- 22 foot radius shall be calculated from one of the following:
- 23 (i) The center point of the driveway where the driveway
- 24 meets the road.
- 25 (ii) If there is no driveway, the point at the street
- 26 <u>directly in front of the front door of the residence or</u>
- 27 business.
- 28 (c) A school may enforce this section through appropriate
- 29 <u>disciplinary action and an appropriate fine after an</u>
- 30 investigation that may include a statement from a school bus

- 1 driver, a student's parent or another student. The statement can
- 2 <u>be made either in writing or verbally to the appropriate school</u>
- 3 official in charge of administering this section, however, the
- 4 report must always include the name of the person making the
- 5 report, the location of the alleged offense, the name or
- 6 physical description, or both, of the alleged offender and the
- 7 time of day that the offense allegedly occurred.
- 8 Section 2. This act shall take effect in 60 days.
