AN ACT

Amending Titles 30 (Fish) and 34 (Game) of the Pennsylvania 1 Consolidated Statutes, in enforcement, further providing for 2 powers and duties of waterways conservation officers and 3 deputies and for powers and duties of enforcement officers. 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: 7 Section 1. Section 901 of Title 30 of the Pennsylvania Consolidated Statutes is amended by adding a subsection to read: 8 § 901. Powers and duties of waterways conservation officers and 10 deputies. 11 12 (c) Exception to the prohibition of interception and 13 disclosure of communications. -- A waterways conservation officer 14 whose duty it is to enforce this title AND WHO HAS RECEIVED 15 TRAINING UNDER 18 PA.C.S. § 5724 (RELATING TO TRAINING) shall be 16 defined as a law enforcement officer for the purpose of 18 Pa.C.S. § 5704(16)(iii) (relating to exceptions to prohibition 17 of interception and disclosure of communications). - 10 enforce this title AND WHO HAS RECEIVED TRAINING UNDER 18
- 11 PA.C.S. § 5724 (RELATING TO TRAINING) shall be defined as a law
- 12 enforcement officer for the purpose of 18 Pa.C.S. § 5704(16)
- 13 (iii) (relating to exceptions to prohibition of interception and
- 14 <u>disclosure of communications</u>). <u>SUCH OFFICERS MAY WEAR BODY</u>
- 15 CAMERAS IN THE PERFORMANCE OF THEIR OFFICIAL DUTIES. This
- 16 subsection shall not apply to a deputy Game Commission officer
- 17 or deputy wildlife conservation officer.

- 19 Section 3. This act shall take effect in 60 days.
