A RESOLUTION

Directing the State Government Committee to conduct a comprehensive study and review of the compensation provisions of the Constitution of Pennsylvania and to make 3 recommendations. 4 WHEREAS, The Constitution of Pennsylvania contains several 5 sections pertaining to the process through which compensation is 6 to be dispensed to public officers, including: Article II, section 8, providing for the compensation of the 8 9 members of the General Assembly; 10 Article III, section 26, providing for the retirement 11 allowances and pensions of members of the General Assembly; 12 Article III, section 27, prohibiting the term extension of 13 any public officer or the increase or decrease in his salary after his election or appointment; 14 15 Article V, section 16, providing for the compensation of 16 justices, judges and justices of the peace; 17 Schedule No. 1, section 17, providing that the General 18 Assembly shall fix and determine the compensation of judges;

Schedule No. 1, section 29, providing for the compensation of

- 1 all State, county, city, ward, borough and township officers;

- 3 WHEREAS, Due to constitutional issues raised after the
- 4 passage of the act of July 7, 2005 (P.L.201, No.44), entitled
- 5 "An act amending Titles 42 (Judiciary and Judicial Procedure),
- 6 46 (Legislature) and 71 (State Government) of the Pennsylvania
- 7 Consolidated Statutes, providing for compensation; and making an
- 8 inconsistent repeal," it is necessary for the General Assembly
- 9 to fully examine these sections of the Constitution of
- 10 Pennsylvania as to their content and meaning; therefore be it
- 11 RESOLVED, That the State Government Committee be directed to
- 12 conduct a comprehensive study and review of the Constitution of
- 13 Pennsylvania relating to the compensation provisions identified
- 14 in this resolution, including any related judicial decisions not
- 15 so identified; and be it further
- 16 RESOLVED, That the committee hold public hearings on this
- 17 issue and determine whether or not constitutional amendments are
- 18 needed to clarify these sections; and be it further
- 19 RESOLVED, That the committee report its findings and
- 20 recommendations to the House of Representatives no later than
- 21 six months after the adoption of this resolution.
