## A RESOLUTION

- Designating May 21, 2014, as "Emergency Medical Services for Children (EMSC) Day" in Pennsylvania.
- 3 WHEREAS, Emergency Medical Services for Children supports
- 4 emergency medical services (EMS), the community-based public
- 5 service whose presence is vital to children in need; and
- 6 WHEREAS, The needs of children are different from the needs
- 7 of adults in medical emergencies; and
- 8 WHEREAS, EMSC promotes the high-level emergency care given by
- 9 EMS providers with pediatric emergency skills; and
- 10 WHEREAS, EMSC assists in training for the use of advanced
- 11 technical equipment and services in preparation to save the life
- 12 of a child; and
- 13 WHEREAS, EMS providers unceasingly prepare to respond to
- 14 children who benefit from the system and return them to an

- 1 optimum level of health; and
- 2 WHEREAS, EMSC works with emergency physicians, emergency
- 3 nurses, social workers, psychologists, rescue personnel,
- 4 emergency medical technicians, paramedics, prehospital nurses,
- 5 air medical personnel, emergency medical responders, emergency
- 6 vehicle operators, firefighters, police officers, educators,
- 7 dispatchers, administrators and others to identify and address
- 8 the issues surrounding the provision of optimal pediatric care;
- 9 and
- 10 WHEREAS, EMSC assists in the development of training,
- 11 programs and guidelines for emergency care providers so that
- 12 children with special health care needs receive timely,
- 13 appropriate care; and
- 14 WHEREAS, It is proper and timely to recognize to the value
- 15 and accomplishments of such dedicated men and women by
- 16 designating Emergency Medical Services for Children Day;
- 17 therefore be it
- 18 RESOLVED, That the House of Representatives designate May 21,
- 19 2014, as "Emergency Medical Services for Children (EMSC) Day"
- 20 with the theme, "EMS: Dedicated for Life" and encourage the
- 21 community to observe this day with appropriate programs,
- 22 ceremonies and activities.
