- 4 WHEREAS, The Borough of Forest City was founded by William J.
- 5 Pentecost in 1864; and
- 6 WHEREAS, This year marks the 150th anniversary of the Borough
- 7 of Forest City; and
- 8 WHEREAS, Forest City embodies a rich history and proud
- 9 heritage of commercial and economic development; and
- 10 WHEREAS, Coal discoveries in the 19th century led Forest City
- 11 to be referred to as "The Gateway to the Anthracite Valley"; and
- 12 WHEREAS, Textiles, dressmaking and shoemaking were critical
- 13 to the 20th century economy of Forest City; and
- 14 WHEREAS, Forest City has successfully transitioned from a
- 15 19th and 20th century industrial economy to a 21st century
- 16 service economy; and

- 1 WHEREAS, As a testament to this successful transition, former
- 2 industrial properties have been repurposed to continue to serve
- 3 Forest City's economic development; and
- 4 WHEREAS, Jerry's Sports Center, the largest sporting goods
- 5 wholesaler in the East, and Karti Sales Company, a manufacturer
- 6 and provider of shower curtains and bath accessories, serve as
- 7 leading examples of the opportunities available for business
- 8 development in Forest City; and
- 9 WHEREAS, The 30-acre Vision 2000 Industrial Park in Forest
- 10 City serves as a hub for future investment, offering developers
- 11 shovel-ready prepared lots with full utility service; and
- 12 WHEREAS, The Vision 2000 Industrial Park serves as a Keystone
- 13 Opportunity Zone and an Enterprise Zone, offering attractive tax
- 14 benefits for businesses looking to establish a presence in
- 15 northeast Pennsylvania; and
- 16 WHEREAS, Forest City will continue to build upon its rich
- 17 150-year history of successful commercial development; therefore
- 18 be it

- 20 important contributions Forest City continues to make to the
- 21 Pennsylvania economy 150 years after its establishment in 1864.
