 PERFORMANCE OF HIS OFFICIAL DUTIES TO INTERCEPT AND RECORD AN
 ORAL COMMUNICATION BETWEEN INDIVIDUALS IN ACCORDANCE WITH THE
 FOLLOWING:

4 <u>ENFORCEMENT OFFICER" MEANS A</u> MEMBER OF THE PENNSYLVANIA
5 STATE POLICE OR AN INDIVIDUAL EMPLOYED AS A POLICE
6 OFFICER WHO HOLDS A CURRENT CERTIFICATE UNDER 53 PA.C.S.
7 CH. 21 SUBCH. D (RELATING TO MUNICIPAL POLICE EDUCATION
8 AND TRAINING).

9 ["RECORDER." AN ELECTRONIC, MECHANICAL OR OTHER 10 DEVICE USED TO STORE AN ORAL COMMUNICATION ON TAPE OR ON 11 SOME OTHER COMPARABLE MEDIUM.]

13 (18) A person to intercept oral communications for 14 disciplinary or security purposes on a school bus or school 15 vehicle, as those terms are defined in 75 Pa.C.S. § 102 16 (relating to definitions), if all of the following conditions 17 are met:

(i) The school board has adopted a policy that

 authorizes audio interception on school buses or school
 vehicles for disciplinary or security purposes.
 (ii) Each school year, the school board notifies
 students and their parents or guardians of the policy, by
 letter mailed to the students' home addresses.

24 (iii) The school board posts a notice that students
 25 may be audiotaped, which notice is clearly visible on
 26 each school bus or school vehicle that is furnished with
 27 audio-recording equipment.

28 This paragraph shall not apply when a school bus or school

29 <u>vehicle is used for a purpose that is not school related.</u>
