## AN ACT

- Amending Title 23 (Domestic Relations) of the Pennsylvania
- Consolidated Statutes, in support matters generally, further 2 3
- providing for information to consumer reporting agency, for
- general administration of support matters; and for expedited 4
- procedure. 5
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- Section 1. Section 4303 of Title 23 of the Pennsylvania 8
- Consolidated Statutes is amended to read:
- 10 § 4303. Information to consumer reporting agency.
- (a) Overdue support. -- Information regarding the name and the 11
- 12 amount of arrearages owed by an obligor shall be provided
- periodically to consumer reporting agencies whenever the obligor 13
- owes overdue support, subject to the following: 14
- 15 (1)The information shall be available only after the
- 16 obligor owing the arrearages has been notified of the
- 17 proposed action and given a period not to exceed 20 days to
- 18 contest the accuracy of the information. The notice shall be
- as provided by local rule of the court of common pleas. 19

- 1 (2) Such information shall not be made available to:
- 2 (i) a consumer reporting agency which the department
- determines not to have sufficient capability to
- 4 systematically and timely make accurate use of such
- 5 information; or
- 6 (ii) an entity which has not furnished evidence
- 7 satisfactory to the department that the entity is a
- 8 consumer reporting agency.
- 9 (b) Petition to provide record of payments. -- An obligor who
- 10 is subject to a support order under this part may petition the
- 11 court as part of the court's support order to direct the
- 12 <u>domestic relations section to provide periodic information to a</u>
- 13 consumer reporting agency that includes the record of payment of
- 14 support to the domestic relations section as provided in section
- 15 4325 (relating to payment of order of support).
- Section 2. Section 4305(a) of Title 23 is amended by adding
- 17 a paragraph to read:
- 18 § 4305. General administration of support matters.
- 19 (a) Powers and duties. -- Subject to any inconsistent general
- 20 rules and to the supervision and direction of the court, the
- 21 domestic relations section shall have the power and duty to:
- 22 \* \* \*
- 23 (12) Subject to approval of the court upon petition of
- an obligor, provide monthly reporting to a credit reporting
- agency concerning the timely payments of support as provided
- in section 4303 (relating to information to consumer
- 27 <u>reporting agency</u>).

- 29 Section 3. Section 4342(q) of Title 23 is amended to read:
- 30 § 4342. Expedited procedure.

- 2 (g) Payment record. -- A copy of the record of support
- 3 payments <u>prepared by the domestic relations section and</u>
- 4 certified as a true copy of the original by the custodian of the
- 5 record is evidence of facts asserted in it and is admissible to
- 6 show whether payments were made in any civil proceeding,
- 7 <u>including</u>, but not limited to, any action under Title 13
- 8 <u>(relating to commercial code) and for purposes of any consumer</u>
- 9 <u>credit reporting</u>.

- 11 Section 4. This act shall take effect in 60 days.
