AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the 4 laws relating thereto," repealing provisions relating to CPR 5 instruction and to cardiopulmonary resuscitation; providing 7 for medical emergency instruction and procedures and for required instruction for CPR and first aid. 8 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: Section 1. Section 1205.4 of the act of March 10, 1949 11 12 (P.L.30, No.14), known as the Public School Code of 1949, added November 22, 2000 (P.L.672, No.91), is repealed: 13 14 [Section 1205.4. CPR Instruction. -- (a) School entities 15 shall be required to offer a cardiopulmonary resuscitation 16 training (CPR) class on school premises at least once every

- Section 2. Section 1424 of the act, added June 30, 2012
- 17 (P.L.684, No.82), is repealed:
- 18 [Section 1424. Cardiopulmonary Resuscitation.--(a) A school
- 19 entity shall have at each school, or in the case of a cyber
- 20 charter school at each location, under its jurisdiction, except
- 21 in extenuating circumstances, one person certified in the use of
- 22 cardiopulmonary resuscitation during regular school hours when
- 23 school is in session and students are present.
- 24 (b) The provisions of 42 Pa.C.S. §§ 8332 (relating to
- 25 nonmedical good Samaritan civil immunity) and 8337.1 (relating
- 26 to civil immunity of school officers or employees relating to
- 27 emergency care, first aid and rescue) shall apply to a person
- 28 who renders cardiopulmonary resuscitation.

- 5 MEDICAL EMERGENCY INSTRUCTION AND PROCEDURES
- 6 <u>Section 1401-A. Definitions.</u>
- 7 The following words and phrases when used in this article
- 8 shall have the meanings given to them in this section unless the
- 9 <u>context clearly indicates otherwise:</u>
- "Automated External Defibrillator" or "AED." A portable
- 11 <u>device that uses electric shock to restore a stable heart rhythm</u>
- 12 to an individual in cardiac arrest.
- 13 "CPR." Cardiopulmonary resuscitation.
- 14 "Department." The Department of Education of the
- 15 Commonwealth.
- 16 <u>"Professional employee."</u> As defined under section 1101(1).
- 17 "School entity." An area vocational-technical school, a
- 18 charter school, a cyber charter school, an intermediate unit, a
- 19 nonpublic school or a school district.
- 20 Section 1402-A. CPR and first aid instruction.
- 21 (a) Instruction. -- All of the following shall apply:
- 22 (1) A school entity shall provide instruction in the
- 23 <u>principles and techniques of CPR and first aid on the school</u>
- 24 premises as necessary to ensure continuous certification of
- 25 all of the following:
- 26 (i) The professional employees of the school entity.
- 27 <u>(ii) The athletic and cheerleading coaches of the</u>
- 28 school entity.
- 29 (2) A school entity shall offer the instruction as an
- 30 option to volunteers of the school entity no less than once

- 1 every three years.
- 2 (b) Documentation of training. -- Completion of training,
- 3 including testing of skills and knowledge, shall be documented
- 4 by the signature and title of a representative of the training
- 5 <u>entity and shall include the date training was completed.</u>
- 6 Documentation shall be retained by the school entity in that
- 7 employee's or volunteer's file. Training shall be conducted by
- 8 any of the following:
- 9 <u>(1) The American Red Cross.</u>
- 10 (2) The American Heart Association.
- 11 (3) Any other certifying agency approved by the
- 12 <u>Department of Health.</u>
- 13 (4) An individual certified to conduct CPR and first aid
- training by the American Red Cross, American Heart
- 15 Association or any other certifying agency approved by the
- 16 Department of Health.
- 17 (c) Continuing education. -- A school entity shall include
- 18 this training in the continuing education plan submitted by the
- 19 school entity to the department under section 1205.1.
- 20 Section 1403-A. Cardiac arrest procedures.
- 21 A school entity shall develop safety procedures to follow in
- 22 responding to a medical emergency involving cardiac arrest,
- 23 including the appropriate response time in administering CPR,
- 24 using an AED or calling a local emergency medical services
- 25 provider, provided that no school entity shall be required to
- 26 establish new procedures under this section if procedures
- 27 currently exist and reasonably fulfill the requirements of this
- 28 section.
- 29 Section 1404-A. AED instruction.
- Notwithstanding the provisions of section 1423(c)(1), a

- 1 <u>school entity that has an AED located in one or more school</u>
- 2 buildings or locations shall assure that no fewer than four
- 3 individuals assigned to each school building or location with an
- 4 AED are trained in the use of an AED.
- 5 <u>Section 1405-A.</u> <u>Donations for CPR and first aid instruction.</u>
- 6 (a) Donations to the department. -- The department may review
- 7 and provide coordination strategies for public and private
- 8 sector efforts to raise and appropriate funds and may enter into
- 9 an agreement with a State agency, private sector organization or
- 10 person as it deems necessary to implement the purposes of this
- 11 article. The department may establish accounts and accept and
- 12 <u>administer gifts, donations or other funds received by the</u>
- 13 <u>department to achieve the purposes of this article.</u>
- 14 <u>(b) Disbursement.--The department shall develop procedures</u>
- 15 for disbursing gifts, donations or other funds to school
- 16 entities. The department may use no more than 1% of the gifts,
- 17 donations or other funds received to implement the procedures.
- 18 (c) Donations to school entities. -- A school entity may
- 19 accept donations, gifts or other funds from the department, a
- 20 State agency or private sector organization to achieve the
- 21 purposes of this article.
- 22 Section 1406-A. Immunity.
- 23 The provisions of 42 Pa.C.S. §§ 8332 (relating to nonmedical
- 24 good samaritan civil immunity) and 8337.1 (relating to civil
- 25 immunity of school officers or employees relating to emergency
- 26 care, first aid and rescue) shall apply to an individual who
- 27 renders CPR or first aid.
- 28 <u>Section 1407-A. Regulations.</u>
- 29 The department may adopt regulations necessary to effectuate
- 30 this article.

- 1 Section 4. The act is amended by adding a section to read:
- 2 <u>Section 1511.2.</u> Required Instruction for CPR and First Aid.
- 3 (a) Beginning with the 2015-2016 school year and each school
- 4 year thereafter, in every secondary public and private school,
- 5 established and maintained in this Commonwealth, completion of
- 6 training and certification in CPR and first aid shall be
- 7 required for student graduation from high school.
- 8 (b) Beginning with the 2015-2016 school year and each school
- 9 year thereafter, each school entity shall provide secondary
- 10 students with training and testing on the principles and
- 11 techniques of CPR and first aid in accordance with subsection
- 12 <u>(c)</u>.
- 13 (c) A training entity shall train and test secondary
- 14 students' knowledge of CPR and first aid. Completion of the
- 15 training shall be documented by the signature and title of the
- 16 representative of the training entity and shall include the date
- 17 when the training was completed. A copy of the documentation
- 18 shall be submitted to the school entity and shall be maintained
- 19 in the student's records.
- 20 (d) The department may adopt regulations necessary to
- 21 effectuate this section.
- 22 (e) The following words and phrases when used in this
- 23 section shall have the meanings given to them in this subsection
- 24 unless the context clearly indicates otherwise:
- 25 <u>"CPR." Cardiopulmonary resuscitation.</u>
- 26 "School entity." An area vocational-technical school, a
- 27 <u>charter school, a cyber charter school, an intermediate unit, a</u>
- 28 nonpublic school or a school district.
- 29 <u>"Training entity." Any of the following:</u>
- 30 (1) The American Red Cross.

2	(3) Any other certifying agency approved by the
3	Department of Health.
4	(4) An individual certified to conduct CPR and first
5	aid training by the American Red Cross, the American
6	Heart Association or any other certifying agency approved
7	by the Department of Health.
8	Section 5. This act shall take effect as follows:
9	(1) The addition of section 1403-A of the act shall take
10	effect in 180 days.
11	(2) The addition of sections 1406-A and 1511.2(d) of the
12	act shall take effect in 30 days.
13	(3) This section shall take effect immediately.
14	(4) The remainder of this act shall take effect in one
