## AN ACT

- 1 Amending Title 51 (Military Affairs) of the Pennsylvania
- 2 Consolidated Statutes, in veterans' pensions and benefits,
- further providing for paralyzed veteran's pension.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 7702 of Title 51 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 7702. [Paralyzed] Amputee and paralyzed veteran's pension.
- 9 (a) Amount and eligibility. -- In addition to any other
- 10 assistance provided by the Commonwealth and in addition to any
- 11 compensation provided by the Federal Government, every amputee
- 12 and paralyzed veteran shall be paid a pension of \$150 per month.
- 13 Applications for the pensions shall be made to and in the form
- 14 prescribed by the department. The Adjutant General shall
- 15 determine the eligibility of every applicant for a pension, and
- 16 his decision in the matter shall be final.
- 17 (b) Regulations.--The Adjutant General shall promulgate such

- 1 regulations as may be necessary to implement this program.
- 2 (c) Definition. -- As used in this section the term "amputee"
- 3 and paralyzed veteran" means any person who served in the
- 4 military or naval forces of the United States, or any woman's
- 5 organization officially connected therewith, and who gave this
- 6 Commonwealth as his or her place of residence at the time of
- 7 entering the military or naval forces of the United States and
- 8 who, while performing duties connected with such service,
- 9 suffered an injury or incurred a disease which resulted in the
- 10 loss or [loss of use of two or more extremities.] the permanent\_
- 11 and severe or complete paralysis of two or more limbs, being
- 12 <u>defined as having at least two limbs with a 40% disability</u>
- 13 compensation rating or higher in each limb as determined and
- 14 certified by the United States Department of Veterans Affairs IN <--
- 15 ACCORDANCE WITH 38 CFR CH. 1 PT. 4 (RELATING TO SCHEDULE FOR
- 16 <u>RATING DISABILITIES</u>), OR ITS <u>SUCCESSOR</u>. The term does not
- 17 include any person separated from the military or naval forces
- 18 of the United States[, or any woman's organization officially
- 19 connected therewith, ] under other than honorable conditions.
- 20 Section 2. This act shall take effect immediately.
