AN ACT

- Amending Titles 65 (Public Officers) and 74 (Transportation) of 1 the Pennsylvania Consolidated Statutes, in ethics standards 2 and financial disclosure, further providing for restricted 3 activities and for statement of financial interests; prescribing penalties; in lobbying disclosure, further providing for definitions and for reporting; and, in Turnpike Commission standards of conduct, further providing for code of conduct. 8 9 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 11 Section 1. The definitions of "aggregate" and "gift" in section 1102 of Title 65 of the Pennsylvania Consolidated 12 13 Statutes are amended and the section is amended by adding 14 definitions to read: § 1102. Definitions. 15 16 The following words and phrases when used in this chapter 17 shall have, unless the context clearly indicates otherwise, the

20 ["Aggregate." The total of all gifts received from a single

- [(5) The name and address of any direct or indirect
 source of income totaling in the aggregate \$1,300 or more.

 However, this provision shall not be construed to require the divulgence of confidential information protected by statute or existing professional codes of ethics or common law privileges.
 - (6) The name and address of the source and the amount of any gift or gifts valued in the aggregate at \$250 or more and the circumstances of each gift. This paragraph shall not apply to a gift or gifts received from a spouse, parent, parent by marriage, sibling, child, grandchild, other family member or friend when the circumstances make it clear that the motivation for the action was a personal or family relationship. However, for the purposes of this paragraph, the term "friend" shall not include a registered lobbyist or an employee of a registered lobbyist.
- 19 The name and address of the source and the amount of 20 any payment for or reimbursement of actual expenses for 21 transportation and lodging or hospitality received in 22 connection with public office or employment where such actual 23 expenses for transportation and lodging or hospitality exceed 24 \$650 in an aggregate amount per year. This paragraph shall 25 not apply to expenses reimbursed by a governmental body or to 26 expenses reimbursed by an organization or association of 27 public officials or employees of political subdivisions which 28 the public official or employee serves in an official 29 capacity.1

- (i) In addition to reporting the totals required under this subsection, the expense report must identify, by name, position and each occurrence, a State official or employee who receives from a principal or lobbyist anything of value which must be included in the statement under section 1105(b)(6) or (7) (relating to statement of financial interests) as implemented by section 1105(d).
- (ii) For purposes of this chapter, the amount referred to in section 1105(b)(7) shall be considered an aggregate amount per year.
- (iii) For purposes of this chapter, the amount referred to in section 1105(b)(7) shall not include the cost of a reception which the State official or employee attends in connection with public office or employment.
- (iv) Written notice must be given to each State official or employee who is listed in an expense report under this paragraph at least seven days prior to the report's submission to the department. Notice under this subparagraph shall include the information which will enable the State official or employee to comply with section 1105(b)(6) and (7). For purposes of this chapter and Chapter 11 (relating to ethics standards and financial disclosure), section 1105(b)(6) and (7) shall constitute mutually exclusive categories. For each category enumerated in paragraph (2)(i), each notice shall include both the amount incurred during the quarter

- and the cumulative amount incurred from January 1 through

- 3 applicable to members and executive-level employees and the
- 4 immediate families of the members and executive-level employees
- 5 to enable them to avoid any perceived or actual conflict of
- 6 interest and to promote public confidence in the integrity and
