A RESOLUTION

- Opposing the International Olympic Committee's decision to eliminate wrestling from the Summer Olympic Games beginning
- 3 in 2020.
- 4 WHEREAS, Wrestling is recognized as one of the world's oldest
- 5 competitive sports dating back to 3000 BC; and
- 6 WHEREAS, Wrestling was one of the original sports of the
- 7 ancient Greek Olympic games and of the first modern Olympic
- 8 games; and
- 9 WHEREAS, Wrestling is one of the world's most diverse sports,
- 10 with participants from almost 200 countries around the world;
- 11 and
- 12 WHEREAS, Over 280,000 high school students in the United
- 13 States participated in wrestling in 2012; and
- 14 WHEREAS, There are over 350 intercollegiate wrestling
- 15 programs in the United States; and
- 16 WHEREAS, Wrestling represents the determination and hard work
- 17 it takes to succeed in life and sport; and

- 1 WHEREAS, More than 9,500 high school students representing
- 2 496 high schools from across this Commonwealth participated in
- 3 wrestling competitions during the 2011-2012 school year; and
- 4 WHEREAS, Pennsylvania is nationally recognized for its
- 5 wrestling tradition and has produced Olympians, NCAA National
- 6 Champions and more NCAA All-Americans than any other state; and
- 7 WHEREAS, The United States has a long, proud and storied
- 8 Olympic wrestling history; and
- 9 WHEREAS, Wrestling epitomizes the spirit of the Olympic
- 10 games; therefore be it
- 11 RESOLVED, That the Senate:
- 12 (1) disagree with the decision of the International
- Olympic Committee's Executive Committee to eliminate
- wrestling as a core sport from the Summer Olympic Games
- 15 beginning in 2020;
- 16 (2) thank the United States Olympic Committee for its
- 17 continued support of wrestling and encourage the United
- 18 States Olympic Committee to work actively to reverse this
- 19 decision; and
- 20 (3) call upon the International Olympic Committee to
- 21 reconsider reinstating wrestling as a core sport of the
- 22 Summer Olympic Games-;
