- (I) THE ENDANGERED SPECIES ACT OF 1973 (PUBLIC LAW
- 7 <u>93-205, 16 U.S.C. § 1531 ET SEQ.).</u>
- 8 (II) THE ACT OF JUNE 23, 1982 (P.L.597, NO.170),
- 9 KNOWN AS THE WILD RESOURCE CONSERVATION ACT.
- 10 (III) 30 PA.C.S. (RELATING TO FISH).
- 11 (IV) 34 PA.C.S. (RELATING TO GAME).
- 12 (2) AN ANIMAL OR PLANT SPECIES PROPOSED FOR LISTING AS
- AN ENDANGERED OR THREATENED SPECIES UNDER THE ENDANGERED
- 14 SPECIES ACT OF 1973.

- 16 "WIND POWER GENERATION SYSTEM." A SYSTEM OF WIND TURBINES
- 17 LARGER THAN 100 KILOWATTS DESIGNED TO COLLECT AND UTILIZE WIND
- 18 POWER FOR THE PURPOSE OF DELIVERING ELECTRICITY TO THE POWER
- 19 GRID TO BE DISTRIBUTED TO AN END USER BY AN ELECTRIC UTILITY OR
- 20 POWER SYSTEM OPERATOR. THE TERM INCLUDES THE FOUNDATION OF A
- 21 WIND TURBINE AND APPURTENANT STRUCTURES, INCLUDING NEW ROADS AND
- 22 BRIDGES, TRANSMISSION LINES, SUBSTATIONS AND OTHER RELATED
- 23 BUILDINGS OR STRUCTURES.
- Section 2. Section 14.1(c)(6) of the act is amended by
- 25 adding a subparagraph to read:
- 26 Section 14.1. Purchase of agricultural conservation easements.

- 28 (c) Restrictions and limitations. -- An agricultural
- 29 conservation easement shall be subject to the following terms,
- 30 conditions, restrictions and limitations:

2	(6) An agricultural conservation easement shall not
3	prevent:

5	(vii) The granting of rights-of-way by the owner of
6	the subject land in and through the land for the
7	installation of or use of a wind power generation system,
8	if all of the following apply:
9	(A) The subject land consists of 50 or more
10	acres.
11	(B) If the subject land consists of less than
12	100 acres, the wind power generation system may be
13	constructed on no more than two acres of the subject
14	<pre>land.</pre>
15	(C) If the subject land consists of 100 or more
16	acres, the wind power generation system may be
17	constructed on no more than two acres of the subject
18	land, plus two additional acres for every 50 acres by
19	which the subject land exceeds 100 acres.
20	(D) If the subject land upon which the wind
21	power generation system is constructed is
22	subsequently subdivided or conveyed or transferred in
23	whole or in part, the subject land upon which the
24	wind power generation system is located must continue
25	to consist of 50 or more acres.
26	(E) THE COMMONWEALTH AGENCY WITH JURISDICTIONAL <
27	AUTHORITY FOR PROTECTING THREATENED AND ENDANGERED
28	SPECIES SHALL CONDUCT A STUDY TO DETERMINE THE
29	PRESENCE OF ENDANGERED OR THREATENED SPECIES AND THE
30	SPECIES' CRITICAL HABITATS IN THE AREA LIKELY TO BE

1	AFFECTED BY THE INSTALLATION AND USE OF THE WIND
2	POWER GENERATION SYSTEM. THE STUDY SHALL FURTHER
3	DETERMINE WHETHER THE INSTALLATION WILL ADVERSELY
4	AFFECT A THREATENED OR ENDANGERED SPECIES OR A
5	THREATENED OR ENDANGERED SPECIES' HABITAT.

7	Section 3. The addition of section 14.1(c)(6)(vii) of the
8	act shall apply to agricultural conservation easements executed
9	after June 29, 1981.
10	Section 4. This act shall take effect in 60 days.
