AN ACT

Amending Title 51 (Military Affairs) of the Pennsylvania 1 Consolidated Statutes, in State Veterans' Commission and 2 Deputy Adjutant General for Veterans' Affairs, further 3 providing for the composition of the State Veterans' 5 Commission. 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: 8 Section 1. Section 1702(b) of Title 51 of the Pennsylvania Consolidated Statutes is amended to read: 10 § 1702. State Veterans' Commission. 11 * * * 12 (b) Composition. -- The commission shall be composed of: 13 The Adjutant General, ex officio, or his designee. - 24 At least one member shall be a female veteran, and at least
