Amending the act of February 9, 1999 (P.L.1, No.1), entitled "An act providing for borrowing for capital facilities; conferring powers and duties on various administrative agencies and officers; making appropriations; and making repeals," in capital facilities, further providing for appropriation for and limitation on redevelopment assistance 7 capital projects and for administration of redevelopment-<-assistance capital projects. 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1. Section 317(b) of the act of February 9, 1999 (P.L.1, No.1), known as the Capital Facilities Debt Enabling 12 Act, amended October 25, 2013 (P.L.648, No.77), is amended to 13 14 read: Section 317. - 13 Section 318. Administration of redevelopment assistance capital
- 14 projects.

- 16 (a.3) Acceptance and grant agreement. Within 30 days of
- 17 receiving notification of approval under subsection (a.2), an
- 18 applicant shall notify the office if the applicant accepts the
- 19 grant. If the applicant notifies the office that it intends to
- 20 accept the grant, the office shall forward to the applicant a
- 21 grant agreement to be executed by the applicant. The grant-
- 22 agreement and any attachments thereto shall include the
- 23 following:
- 24 (1) The name and address of who will administer the
- 25 grant.
- 26 (2) A statement and proof of local funding.
- 27 (3) An itemized statement of cost associated with the
- 28 project.
- 29 (4) A contract obligating the applicant to use the grant

1 (4.1) A signed affidavit stating that the applicant will hold at least one public informational meeting as provided 2 under subsection (1) for the project and an additional public 3 informational meeting as necessary under subsection (m) for 4 5 the project. 6 (5) A request for any other information the office may 7 require. * * * 8 9 (1) Public informational meeting. Before the construction 10 of an approved redevelopment assistance capital project, at least one public informational meeting shall be held within a 11 ten mile radius of the project site. If no suitable venue is 12 available within a ten mile radius of the project site, the 13 Secretary of the Budget, in consultation with the applicant and 14 the State Senator and the State Representative in the district 15 where the project will be located, may expand the radius by a 16 reasonable distance. Any expenses for the public informational 17 18 meeting shall be paid by the applicant. 19 (m) Additional requirements. If an applicant significantly alters an approved redevelopment assistance capital project 20 after a contract has been executed, the applicant shall hold an 21 additional public informational meeting before construction for 22 the purposes of discussing with the public the alteration to the 23 24 project.
