4	"Emergency medical services personnel." The term includes,
5	but is not limited to, doctors, residents, interns, registered

7	attendants and operators, paramedics, emergency medical
8	technicians and members of a hospital security force while
9	working within the scope of their employment.
10	"Health care practitioner." As defined in section 103 of the
11	act of July 19, 1979 (P.L.130, No.48), known as the Health Care
12	Facilities Act.
13	Section 2. This act shall take effect in 60 days.
