## AN ACT

1 2 3	Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in licensing of drivers, further providing for application for driver's license or learner's permit, for
4 5	issuance and content of driver's license and for expiration and renewal of drivers' licenses.
6	The General Assembly of the Commonwealth of Pennsylvania
7	hereby enacts as follows:
8	Section 1. Sections 1506(a) and (a.1), 1510(f) and (i) and
9	1514(e) of Title 75 of the Pennsylvania Consolidated Statutes
10	are amended to read:
11	§ 1506. Application for driver's license or learner's permit.
12	(a) Form and contentEvery application for a learner's
13	permit or driver's license shall be made upon a form furnished
14	by the department and shall contain such information as the
15	department may require to determine the applicant's identity,
16	competency and eligibility. The form shall allow for submission
17	of a Social Security number or a taxpayer identification number.
18	The form may also provide for inclusion of personal medical

1 information and other information of use in an emergency.

2 [(a.1) Noncitizen application.--A person who is not a 3 citizen of the United States may apply for a Pennsylvania driver's license upon establishing the person's lawful presence 4 in the United States and this Commonwealth. The department may 5 6 issue a license if the person will lawfully be in the United 7 States for a period of one year or more after the date of the 8 application or for a shorter period of time if deemed 9 appropriate by the department.]

11 § 1510. Issuance and content of driver's license.

13 (f) Waiver.--Notwithstanding the provisions of subsection 14 (a), the department shall issue a driver's license to an 15 otherwise eligible person who has no Social Security number if the person submits a [waiver obtained from the Federal 16 Government permitting him not to have a Social Security number. 17 18 The department may require other identifiers, including, but not 19 limited to, a taxpayer identification number, before issuing the license.] Federal taxpayer identification number or a Federal 20 waiver for nonissuance of a Social Security number for reasons 21 of religion. If an applicant does not have a taxpayer 22 23 identification number, documents or a combination of documents 24 that reliably proves the applicant's name and date of birth shall be submitted. The department shall accept the following 25 26 documents and shall only require a combination of them if necessary to establish name and date of birth of an applicant: 27 28 (1) A valid foreign passport from the person's country\_ 29 of citizenship. (2) A valid consular identification document. 30

1 (3) A certified record of the applicant's birth, 2 marriage, adoption or divorce, including a translation if 3 necessary. (4) Alternative proof of identity. The department shall 4 establish a secondary review process for an applicant to 5 submit alternative proof of identity when the identifying\_ 6 7 documents outlined in this subsection are not available. \* \* \* 8 9 Issuance to noncitizens. -- A license issued in [(i)] 10 accordance with section 1506(a.1) (relating to application for 11 driver's license or learner's permit) may contain an indication 12 that the license was issued to the person who is not a citizen 13 of the United States and who has credentials or documents issued 14 by the Immigration and Naturalization Service or its successor.] 15 \* \* \* 16 § 1514. Expiration and renewal of drivers' licenses. \* \* \* 17 [(e) Noncitizen license expiration and renewal.--18 19 Except as otherwise provided, a license issued on (1)20 the basis of Immigration and Naturalization Service (INS) 21 credentials or documents shall expire on the date appearing 22 on the INS credentials or documents provided by the applicant 23 under section 1506(a.1) (relating to application for driver's 24 license or learner's permit). 25 If the expiration date of the INS credentials or (2)26 documents exceeds four years, the license shall expire one 27 day after the applicant's date of birth but not more than 28 four years from the date of issuance of the license. 29 Upon presenting INS credentials or documents (3) 30 indicating continued legal presence in the United States, the

1 person may apply for a renewal of the license.

(4) If a person has been granted permanent legal status
in the United States by the INS, the department may in its
discretion require the person to present his INS credentials
or documents for only the first license application or
renewal.

7 (5) License renewals issued under this subsection shall 8 be for the length of time as set forth in paragraph (1) or 9 (2).]

10 Section 2. This act shall take effect in 60 days.
