AN ACT

- 1 Providing for the English language as the official language of 2 the Commonwealth; and imposing a certain restriction on use
- of appropriated funds.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Official
- 8 Language Act.
- 9 Section 2. Legislative findings.
- 10 The General Assembly finds and declares as follows:
- 11 (1) The people of the United States have brought to this
- 12 nation the cultural heritage of many nations.
- 13 (2) The people of the United States, despite their many
- 14 differences, have lived together harmoniously and
- 15 productively as citizens of one nation.
- 16 (3) The traditional and common language of the United
- 17 States and of this Commonwealth is English.

- 1 (4) A knowledge of the common language is essential to
- 2 full exercise of constitutional freedoms, informed and
- 3 knowledgeable empowerment as voters, citizen checks against
- 4 government abuses and individual prosperity and independence.
- 5 (5) The English language has been our strongest bond to
- 6 one another as fellow citizens and has contributed
- 7 substantially to national unity and societal cohesiveness.
- 8 (6) English has been this nation's language by custom
- 9 only and warrants special legal protection.
- 10 (7) Government has a fiduciary responsibility to the
- 11 citizenry to ensure that it operates as efficiently as
- 12 possible, and the growth of multiple language bureaucracies
- and printing represents an abrogation of this fiduciary
- 14 responsibility.
- 15 (8) The Commonwealth and its municipalities and the
- 16 Federal Government also have a responsibility to ensure that
- 17 citizens have opportunities to learn English.
- 18 Section 3. Purpose.
- 19 (a) Unifying role. -- It is the purpose of this act to
- 20 preserve, protect and strengthen the unifying role of English as
- 21 the official language of this Commonwealth.
- 22 (b) Rights preserved. -- This act shall not be construed in
- 23 any way to infringe on the rights of citizens, who have every
- 24 right to choose their own primary language, in the use of
- 25 language for private conduct, nor shall this act be used to
- 26 dictate language policies for the operation and administration
- 27 of organizations or businesses in the unregulated private
- 28 sector.
- 29 Section 4. Definitions.
- The following words and phrases when used in this act shall

- 1 have the meanings given to them in this section unless the
- 2 context clearly indicates otherwise:
- 3 "Official acts of government." Any of the following:
- 4 (1) Actions of the Commonwealth and of its political
- 5 subdivisions that carry the full weight and authority of law.
- 6 (2) Official documents recorded and maintained by the
- 7 Commonwealth and its political subdivisions for the public
- 8 domain, including tax records, professional licenses, deeds,
- 9 real estate records, publicly probated wills and other
- documents of the court systems and public proceedings of the
- governing bodies of the Commonwealth and its political
- 12 subdivisions.
- 13 Section 5. Designation of language of official acts.
- 14 English is hereby recognized as the official language of the
- 15 Commonwealth and shall also be designated as the language of
- 16 official acts of government.
- 17 Section 6. Policies.
- 18 The Commonwealth and its political subdivisions shall make no
- 19 policies expressing a preference for any language other than
- 20 English or diminishing or ignoring the unifying role of English
- 21 as designated in this act, subject to the limitations in section
- 22 8.
- 23 Section 7. Enforcement.
- 24 Elected and appointed officers of the Commonwealth and its
- 25 political subdivisions shall take all reasonable steps to ensure
- 26 that the role of English as the official language is preserved
- 27 and enhanced.
- 28 Section 8. Limitations.
- 29 The provisions of this act shall not apply to the following:
- 30 (1) When Federal law imposes contrary provisions.

- 1 (2) When the public safety, health or justice requires
- 2 the use of other languages.
- 3 (3) Instruction in foreign language courses.
- 4 (4) Instruction designed to aid students with limited
- 5 English proficiency in their transition and integration into
- 6 the education system.
- 7 (5) The promotion of international commerce or tourism.
- 8 (6) When using terms of art or phrases from languages
- 9 other than English.
- 10 (7) The preservation or use of Native Alaskan or Native
- 11 American languages as defined in the Native American
- 12 Languages Act of 1990 (Public Law 101-477).
- 13 (8) Unofficial communications, through any medium,
- between a person and a member of the General Assembly or any
- officer or agent of the Commonwealth and its political
- subdivisions, as long as official acts of government are
- 17 performed in English.
- 18 Section 9. Restrictions on use of appropriated funds.
- 19 No appropriation of the General Assembly may be expended to
- 20 promote the use of or demonstrate a preference for any language
- 21 other than the official language, subject to the limitations in
- 22 section 8.
- 23 Section 10. Effective date.
- This act shall take effect in 90 days.
