- 19 "SOLDIER." A PERSON WHO SERVED OR HEREAFTER SERVES IN THE
- 20 ARMED FORCES OF THE UNITED STATES, OR IN ANY WOMEN'S
- 21 ORGANIZATION OFFICIALLY CONNECTED THEREWITH, DURING ANY WAR OR
- 22 ARMED CONFLICT IN WHICH THE UNITED STATES ENGAGED AND WHO WAS
- 23 RELEASED FROM ACTIVE DUTY UNDER HONORABLE CONDITIONS, OTHER THAN
- 24 FROM PERIODS OF ACTIVE DUTY FOR TRAINING, OR WITH AN HONORABLE
- 25 DISCHARGE FROM SUCH SERVICE, OR A PERSON WHO SO SERVED OR
- 26 HEREAFTER SERVES IN THE ARMED FORCES OF THE UNITED STATES, OR IN
- 27 ANY WOMEN'S ORGANIZATION OFFICIALLY CONNECTED THEREWITH, SINCE
- 28 JULY 27, 1953, INCLUDING SERVICE IN VIETNAM, AND WHO HAS AN
- 29 HONORABLE DISCHARGE FROM SUCH SERVICE. QUALIFYING PERIODS OF
- 30 SERVICE DURING A WAR OR ARMED CONFLICT, FOR PURPOSES OF THIS

- 1 DEFINITION, WILL BE DESIGNATED BY THE DEPARTMENT OF MILITARY AND
- 2 VETERANS AFFAIRS.
- 3 "SPOUSE OF A DISABLED VETERAN." THE SPOUSE OF A VETERAN WHO
- 4 HAS BEEN CLASSIFIED BY THE UNITED STATES DEPARTMENT OF VETERANS
- 5 AFFAIRS' VETERANS BENEFITS ADMINISTRATION AS HAVING A PERMANENT
- 6 TOTAL DISABILITY AND IS A UNITED STATES CITIZEN.
- 7 "SURVIVING SPOUSE." A SPOUSE OF A DECEASED SOLDIER.
- 8 "VETERAN." AN INDIVIDUAL WHO HAS SERVED IN THE ARMED FORCES
- 9 OF THE UNITED STATES, INCLUDING A RESERVE COMPONENT AND NATIONAL
- 10 GUARD, AND WHO HAS BEEN DISCHARGED OR RELEASED FROM THE SERVICE
- 11 UNDER CONDITIONS OTHER THAN DISHONORABLE.
- 12 "VETERANS' PREFERENCE EMPLOYMENT POLICY." A VOLUNTARY POLICY
- 13 ADOPTED BY A PRIVATE EMPLOYER FOR HIRING, PROMOTING OR RETAINING
- 14 <u>A VETERAN, A SPOUSE OF A DISABLED VETERAN OR A SURVIVING SPOUSE</u>
- 15 OVER ANOTHER QUALIFIED APPLICANT OR EMPLOYEE.
- 16 § 7203. VETERANS' PREFERENCE PRIVATE EMPLOYMENT POLICY.
- 17 (A) AUTHORITY.--A PRIVATE EMPLOYER MAY ADOPT AND APPLY A
- 18 VETERANS' EMPLOYMENT POLICY.
- 19 (B) POLICY.--A VETERANS' PREFERENCE EMPLOYMENT POLICY SHALL:
- 20 <u>(1)</u> BE IN WRITING;
- 21 (2) REQUIRE THE INCLUSION OF A STATEMENT IN ANY JOB
- 22 POSTING THAT INDICATES THAT THE EMPLOYER HAS AND APPLIES A
- 23 VETERANS' PREFERENCE EMPLOYMENT POLICY;
- 24 (3) BE PROVIDED TO THE APPLICANT AT TIME OF HIRING AND
- 25 PROVIDED TO ALL EMPLOYEES ON AN ANNUAL BASIS; AND

- 3 A VETERAN, SPOUSE OF A DISABLED VETERAN OR SURVIVING SPOUSE
- 4 SHALL SUBMIT THE DD 214 OF THE VETERAN TO A PRIVATE EMPLOYER
- 5 WITH A VETERANS' PREFERENCE EMPLOYMENT POLICY FOR CONSIDERATION
- 6 BY THE EMPLOYER.

- "Veteran." [An individual who served on active duty in the
- 14 United States Armed Forces, including any of the following:
- 15 (1) A reservist or member of the National Guard who was
- discharged or released from the service under honorable
- 17 conditions.
- 18 (2) A reservist or member of the National Guard who
- 19 completed an initial term of enlistment or qualifying period
- of service.
- 21 (3) A reservist or member of the National Guard who was
- 22 disabled in the line of duty during training.] An individual
- 23 who served in the United States Armed Forces, including a
- reserve component or the National Guard, and who was
- 25 <u>discharged or released from service under conditions other</u>

- "Veteran-owned small business." A small business owned and
- 28 controlled by a veteran or veterans.

- 25 business shall be exempt from the payment of a business fee.
- 26 (b) Proof.--A veteran or reservist must provide the
- 27 department OR LICENSING AUTHORITY OF A POLITICAL SUBDIVISION <--
- 28 with proof of the veteran's or reservist's status using any of
- 29 the following WITH ANY BUSINESS APPLICATION:
- 30 (1) A copy of a Federal DD-214 form.

- 1 (2) A copy of a Federal NGB-22 form.
- 2 (3) A valid Federal Veterans' Administration card.
- 3 <u>(4) A valid Department of Defense-issued military</u>
- 4 <u>identification card.</u>
- 5 (c) Status.--The Department of State OR LICENSING AUTHORITY <--
- 6 OF A POLITICAL SUBDIVISION, in consultation with other
- 7 Commonwealth agencies, may determine an applicant's status as a
- 8 <u>veteran or reservist in accordance with this section.</u>
- 9 <u>(d) Offenses.--</u>
- 10 (1) A person who fraudulently obtains a business fee
- 11 <u>exemption commits a misdemeanor of the third degree.</u>
- 12 (2) A person assigning, transferring or attempting to
- assign or transfer a business fee exemption or using or
- 14 <u>attempting to use a business fee exemption contrary to this</u>
- 15 <u>section commits a misdemeanor of the third degree.</u>
- (e) Reporting. -- The Department of State shall annually
- 17 determine the total number of business fee exemptions issued
- 18 under this section. APPLIED FOR AND ISSUED AND THE TOTAL DOLLAR <--
- 19 AMOUNT OF THE EXEMPTIONS UNDER THIS SECTION AND SUBMIT A REPORT
- 20 TO THE CHAIR AND MINORITY CHAIR OF THE VETERANS AFFAIRS AND
- 21 EMERGENCY PREPAREDNESS COMMITTEE OF THE SENATE AND THE CHAIR AND
- 22 MINORITY CHAIR OF THE VETERANS AFFAIRS AND EMERGENCY
- 23 PREPAREDNESS COMMITTEE OF THE HOUSE OF REPRESENTATIVES. THE
