AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in school health services, further providing for definitions and providing for education of 6 school employees in diabetes care and management, for 7 diabetes care in schools, for possession and use of diabetes 8 medication and monitoring equipment, for liability, for 9 coordinating, supervising or educating not considered 10 delegation and for diabetes care in nonpublic schools. 11 12 The General Assembly of the Commonwealth of Pennsylvania 13 hereby enacts as follows: 14 Section 1. Section 1401 of the act of March 10, 1949 15 (P.L.30, No.14), known as the Public School Code of 1949, is 16 amended by adding clauses to read: 17 Section 1401. Definitions. -- As used in this article --* * * 18 (13) "Diabetes medical management plan" means a document 19

- 1 describing the medical orders or diabetes regimen developed and
- 2 signed by the student's health care practitioner and parent or
- 3 quardian.
- 4 (14) "Service agreement" means a student's section 504
- 5 service agreement pursuant to section 504 of the Rehabilitation
- 6 Act of 1973 (Public Law 93-112, 29 U.S.C. § 794) and 22 Pa. Code
- 7 Ch. 15 (relating to protected handicapped students).
- 8 (15) "Health care practitioner" means the term as defined
- 9 under section 103 of the act of July 19, 1979 (P.L.130, No.48),
- 10 known as the Health Care Facilities Act.
- 11 Section 2. The act is amended by adding sections to read:
- 12 Section 1414.3. Education of School Employes in Diabetes
- 13 Care and Management. -- (a) Within one hundred twenty (120) days
- 14 of the effective date of this section, the Department of Health,
- 15 in coordination with the Department of Education, shall make
- 16 <u>educational modules and guidelines for the instruction of school</u>
- 17 employes in diabetes care and treatment available on its
- 18 publicly accessible Internet website. The educational modules
- 19 shall include instruction in a school entity's obligations under
- 20 22 Pa. Code § 12.41 (relating to student services) and its
- 21 responsibilities to comply with section 504 of the
- 22 Rehabilitation Act of 1973 (Public Law 93-112, 29 U.S.C. § 794)
- 23 and 22 Pa. Code Ch. 15 (relating to protected handicapped
- 24 students). At a minimum, the educational modules shall include
- 25 instruction in:
- 26 (1) An overview of all types of diabetes.
- 27 (2) Means of monitoring blood glucose.
- 28 (3) The symptoms and treatment for blood glucose levels
- 29 outside of target ranges as well as hypoglycemia, hyperglycemia
- 30 and other potential emergencies.

- 1 (4) Techniques on administering glucagon and insulin.
- 2 (b) The school nurse, in consultation with the chief school
- 3 <u>administrator or a designee, may identify at least one school</u>
- 4 employe who is not the school nurse and who does not need to be
- 5 <u>a licensed health care practitioner in each school building</u>
- 6 attended by a student with diabetes. If the school building
- 7 <u>attended by a student with diabetes does not have a FULL-TIME</u> <--
- 8 school nurse, the chief school administrator may, but is not
- 9 <u>required to, consult with a THE school nurse in a different</u> <--
- 10 ASSIGNED TO THAT school building to identify at least one school <--
- 11 employe in the school building. An identified employe shall
- 12 <u>complete the annual educational modules outlined in subsection</u>
- 13 (a) or annual education offered by a licensed health care
- 14 practitioner with expertise in the care of diabetes that
- 15 <u>includes substantially the same information as outlined in</u>
- 16 subsection (a).
- 17 (c) A school employe who is not a licensed health care
- 18 practitioner and who has successfully completed the education
- 19 modules under subsection (a) or annual education offered by a
- 20 licensed health care practitioner with expertise in the care of
- 21 diabetes that includes substantially the same information as
- 22 outlined in subsection (a) may be designated in a student's
- 23 service agreement to administer diabetes medications, use
- 24 monitoring equipment and provide other diabetes care. A school
- 25 entity may require the designated employe to complete the annual
- 26 educational modules or annual education from a licensed health
- 27 <u>care practitioner</u>, or both, in the administration of diabetes
- 28 medications, use of monitoring equipment and provision of other
- 29 <u>diabetes care</u>. Education provided to school employes shall be
- 30 coordinated by the chief school administrator or a designee.

- 1 School entities may include the education in the continuing
- 2 PROFESSIONAL education plan submitted by the school entity to

- 3 the Department of Education under section 1205.1.
- 4 (d) Notwithstanding any other statute or regulation
- 5 restricting the functions that may be performed by persons other
- 6 than licensed health care practitioners, school employes who
- 7 have completed the education requirements under this section may
- 8 perform diabetes care for students. School employes who are not
- 9 licensed health care practitioners shall only be authorized to
- 10 administer diabetes medications via injection or infusion
- 11 <u>following annual education by a licensed health care</u>
- 12 practitioner with expertise in the care of diabetes, and
- 13 <u>following the school's receipt of written authorization from</u>
- 14 both the student's health care practitioner and parent or
- 15 guardian that an educated school employe, who is not a licensed
- 16 health care practitioner, may administer specified medications.
- 17 (e) For purposes of this section, "school entity" means a
- 18 school district, intermediate unit, area vocational-technical
- 19 school, charter school or cyber charter school.
- 20 Section 1414.4. Diabetes Care in Schools. -- (a) A parent or
- 21 quardian of a student with diabetes who desires that the student
- 22 receive diabetes-related care in a school setting shall provide
- 23 the school entity with written authorization for the care and
- 24 instructions from the student's health care practitioner,
- 25 consistent with the school entity's policies regarding the
- 26 provision of school health services. The required authorizations
- 27 may be submitted as part of a diabetes medical management plan.
- 28 (b) All diabetes-related care provided to students shall be
- 29 consistent with the school health program established by the
- 30 governing body of the school entity and any accommodations

- 1 outlined in a student's service agreement.
- 2 (c) A student's service agreement may require a school
- 3 entity to provide the driver of a school bus or school vehicle,
- 4 who provides transportation to a student with diabetes, with an
- 5 information sheet that:
- 6 (1) Identifies the student with diabetes.
- 7 (2) Identifies potential emergencies that may occur as a
- 8 <u>result of the student's diabetes and the appropriate responses</u>
- 9 to such emergencies.
- 10 (3) Provides the telephone number of a contact person in
- 11 case of an emergency involving the student with diabetes.
- 12 <u>(d) For purposes of this section:</u>
- "School bus" means a school bus as defined in 75 Pa.C.S. §
- 14 <u>102 (relating to definitions).</u>
- "School entity" means a school district, intermediate unit,
- 16 <u>area vocational-technical school, charter school or cyber</u>
- 17 charter school.
- 18 "School vehicle" means a school vehicle as defined in 75
- 19 Pa.C.S. § 102.
- 20 <u>Section 1414.5. Possession and Use of Diabetes Medication</u>
- 21 and Monitoring Equipment. -- (a) A school entity shall require
- 22 the parent or quardian of a student with diabetes who desires
- 23 that the student possess and self-administer diabetes medication
- 24 and monitoring equipment in a school setting to provide the
- 25 <u>following:</u>
- 26 (1) A written statement from the student's health care
- 27 practitioner that provides the name of the drug, the dose, the
- 28 times when the medication is to be taken or the monitoring
- 29 equipment to be used, the specified time period for which the
- 30 medication or monitoring equipment is authorized to be used and

- 1 the diagnosis or reason the medicine or monitoring equipment is
- 2 <u>needed. The student's health care practitioner shall indicate</u>
- 3 the potential of any serious reaction to the medication that may
- 4 <u>occur, as well as any necessary emergency response. The</u>
- 5 <u>student's health care practitioner shall state whether the</u>
- 6 student is competent to self-administer the medication or
- 7 monitoring equipment and whether the student is able to practice
- 8 proper safety precautions for the handling and disposal of the
- 9 <u>medication and monitoring equipment.</u>
- 10 (2) A written request from the parent or quardian that the
- 11 school entity comply with the direction of the student's health
- 12 <u>care practitioner. The parent's request shall include a</u>
- 13 <u>statement relieving the school entity or any school employe of</u>
- 14 any responsibility for the prescribed medication or monitoring
- 15 equipment and acknowledging that the school entity bears no
- 16 <u>responsibility for ensuring that the medication is taken by the</u>
- 17 student and the monitoring equipment is used.
- 18 (3) A demonstration of competency by the student satisfying
- 19 the school nurse that the student is capable of self-
- 20 administration of the medication and use of the monitoring
- 21 equipment.
- 22 (4) A written acknowledgment by the student that the student
- 23 has received instruction from the student's health care
- 24 practitioner on proper safety precautions for the handling and
- 25 disposal of the medications and monitoring equipment. The
- 26 written acknowledgment shall also contain a provision stating
- 27 that the student will not allow other students to have access to
- 28 the medication and monitoring equipment and that the student
- 29 understands appropriate safeguards.
- 30 (b) A school entity may revoke or restrict a student's

- 1 privileges to possess or self-administer diabetes medication and
- 2 monitoring equipment due to noncompliance with school rules and
- 3 provisions of a student's service agreement or due to
- 4 <u>demonstrated unwillingness or inability of the student to</u>
- 5 safeguard the medication and monitoring equipment from access by
- 6 other students.
- 7 (c) A school entity that restricts a student from possessing
- 8 <u>and self-administering diabetes medication and monitoring</u>
- 9 <u>equipment pursuant to subsection (b) shall ensure that the</u>
- 10 diabetes medication or monitoring equipment is appropriately
- 11 stored in a readily accessible place in the school building
- 12 attended by the student. The school entity shall notify
- 13 appropriate school employes regarding the location of the
- 14 <u>diabetes medication and monitoring equipment and means to access</u>
- 15 them.
- 16 (d) For purposes of this section, "school entity" means a
- 17 <u>school district, intermediate unit, area vocational-technical</u>
- 18 school, charter school or cyber charter school.
- 19 Section 1414.6. Liability. -- Nothing in sections 1414.3,
- 20 1414.4 or 1414.5 shall be construed to create, establish or
- 21 expand any civil liability on the part of any school entity or
- 22 school employe.
- 23 Section 1414.7. Coordinating, Supervising or Educating Not
- 24 Considered Delegation. -- (a) Notwithstanding any other law to
- 25 the contrary, coordinating or supervising the provision of
- 26 diabetes care by school employes authorized in sections 1414.3
- 27 and 1414.4 and providing education in accordance with section
- 28 1414.3 shall not be construed as a delegation by a licensed
- 29 health care practitioner.
- 30 (b) A licensed health care practitioner who, acting in

- 1 compliance with sections 1414.3 and 1414.4, coordinates or
- 2 <u>supervises care for a student or provides education to a school</u>
- 3 employe shall not be subject to any criminal or civil liability
- 4 or any professional disciplinary action for the same.
- 5 <u>Section 1414.8. Diabetes Care in Nonpublic Schools.--(a) A</u>
- 6 nonpublic school may comply with the education of school
- 7 <u>employes and provision of diabetes-related care to a student</u>
- 8 with diabetes required under sections 1414.3, 1414.4 and 1414.5.
- 9 A written education plan that outlines the aids and related
- 10 services required to meet the academic needs of the student with
- 11 <u>diabetes may take the place of a service agreement for a student</u>
- 12 with diabetes attending a nonpublic school unless a service
- 13 <u>agreement is otherwise required under law or regulation.</u>
- 14 (b) Nothing in section 1414.3, 1414.4, 1414.5, 1414.6 or
- 15 this section shall be construed to do any of the following:
- 16 (1) Create, establish or expand any obligations on the part
- 17 of any nonpublic school to comply with section 504 of the
- 18 Rehabilitation Act of 1973 (Public Law 93-112, 29 U.S.C. § 794).
- 19 (2) Create, establish, result in or expand any contractual
- 20 obligations on the part of any nonpublic school.
- 21 (c) No nonpublic school employe or nonpublic school shall be
- 22 <u>liable for civil damages as a result of the activities</u>
- 23 authorized by sections 1414.3, 1414.4 and 1414.5, except that an
- 24 <u>employe may be liable for willful misconduct.</u>
- 25 Section 3. This act shall take effect in 60 days.
