AN ACT

- Designating a bridge on that portion of State Route 1026, Section 004 over the Cocalico Creek, Denver Borough, and West Cocalico Township, Lancaster County, as the Samuel L. Snyder Memorial Bridge.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Samuel L. Snyder Memorial Bridge.
- 8 (a) Findings.--The General Assembly finds and declares as
- 9 follows:
- 10 (1) Samuel L. Snyder was born on February 12, 1882, in
- 11 East Cocalico Township, Lancaster County. Mr. Snyder was a
- 12 building contractor, developer and realtor in Denver,
- 13 Pennsylvania, for nearly six decades. It is estimated that he
- built approximately 200 homes in the Denver area alone.
- 15 (2) Mr. Snyder served as the Fire Chief for the Denver
- 16 Fire Company for 33 years and held the title of honorary

- 1 chief at the time of his death in 1965.
- 2 (3) Mr. Snyder donated the land on which the new fire
- 3 house was built and served as a trustee of the Lancaster
- 4 County Firemen's Association. He was also a member of the
- 5 Firemen's Association of Pennsylvania, the Keystone State
- 6 Fire Chiefs Association and the International Association of
- 7 Fire Chiefs.
- 8 (4) He was a leader in Masonic organizations, a charter
- 9 member of the Denver Lions Club since 1926, as well as a past
- 10 president and a vice president of the Lancaster Automobile
- 11 Club. He served on the council of the St. John's Lutheran
- 12 Church in Denver Borough and contributed funding to assist
- 13 the St. John's Evangelical and Reformed Church and the
- 14 Trinity Evangelical United Brethren Church in Denver.
- 15 (5) Following World War II, there was a movement in
- Denver Borough for a community park. Mr. Snyder donated 15
- 17 acres of land for what is now the Denver Memorial Park and
- 18 Playground, as well as leading efforts to develop the park.
- 19 (6) Mr. Snyder died on February 19, 1965, at the age of
- 20 83.
- 21 (b) Designation. -- The bridge located on that portion of
- 22 State Route 1026, Section 004 over the Cocalico Creek, Denver
- 23 Borough, and West Cocalico Township, Lancaster County, is
- 24 designated as the Samuel L. Snyder Memorial Bridge.
- 25 (c) Signs. -- The Department of Transportation shall erect and
- 26 maintain appropriate signs displaying the name of the bridge to
- 27 traffic in both directions on the bridge.
- 28 Section 2. Effective date.
- 29 This act shall take effect in 60 days.
