AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in general provisions, further providing for definitions; in licensing of drivers, further providing for classes of licenses and for examination of applicant for 4 driver's license; in special vehicles and pedestrians, 5 providing for certain passengers prohibited in autocycles; and, in accidents and accident reports, further providing for accident report forms and for department to compile, tabulate 8 and analyze accident reports. - hereby enacts as follows: 11
- 12 Section 1. The definition of "motorcycle" in section 102 of
- 13 Title 75 of the Pennsylvania Consolidated Statutes is amended
- and the section is amended by adding a definition to read: 14
- § 102. Definitions. 15
- 16 Subject to additional definitions contained in subsequent
- 17 provisions of this title which are applicable to specific
- 18 provisions of this title, the following words and phrases when
- used in this title shall have, unless the context clearly 19

- 1 indicates otherwise, the meanings given to them in this section:
- 2 * * *
- 3 "Autocycle." A three-wheeled motorcycle that has a steering
- 4 wheel and seating that does not require the operator to straddle
- 5 or sit astride.
- 6 * * *
- 7 "Motorcycle." A motor vehicle having a seat or saddle for
- 8 the use of the rider and:
- 9 (1) designed to travel on not more than three wheels in
- 10 contact with the ground; or
- 11 (2) designed to travel on two wheels in contact with the
- 12 ground which is modified by the addition of two stabilizing
- wheels on the rear of the motor vehicle.
- 14 The term includes an autocycle.

- Section 2. Section 1504(c) and (d) of Title 75 are amended
- 17 to read:
- 18 § 1504. Classes of licenses.
- 19 * * *
- 20 (c) Qualifications of applicants.--
- 21 (1) The department shall establish by regulation the
- 22 qualifications necessary for the safe operation of the
- various types, sizes or combinations of vehicles and the
- 24 manner of examining applicants to determine their
- 25 qualifications for the type or general class of license
- applied for.
- 27 (2) The qualifications for the safe operation of an
- 28 <u>autocycle shall be the same as for any single vehicle with a</u>
- 29 gross vehicle weight rating of not more than 26,000 pounds or
- 30 any combination of vehicles that does not meet the definition

- of either Class A or Class B of this section.
- 2 (d) Number and description of classes.--Licenses issued by 3 the department shall be classified in the following manner:
- (1) Class A.--A Class A license shall be issued to those persons 18 years of age or older who have demonstrated their qualifications to operate any combination of vehicles with a gross vehicle weight rating of 26,001 pounds or more, provided the gross vehicle weight rating of the vehicle or vehicles being towed is in excess of 10,000 pounds.
 - (i) The holder of a Class A license shall be deemed qualified to operate those vehicles for which a Class B or Class C license is issued.
 - (ii) Where required under this title, appropriate endorsements must be obtained.
 - (2) Class B.--A Class B license shall be issued to those persons 18 years of age or older who have demonstrated their qualifications to operate any single vehicle with a gross vehicle weight rating of 26,001 pounds or more or any such vehicle towing a vehicle having a gross vehicle weight rating of not more than 10,000 pounds.
 - (i) The holder of a Class B license shall be deemed qualified to operate those vehicles for which a Class C license is issued.
 - (ii) Where required under this title, appropriate endorsements must be obtained.
 - (3) Class C.--A Class C license shall be issued to those persons 18 years of age or older, except as provided in section 1503 (relating to persons ineligible for licensing; license issuance to minors; junior driver's license), who have demonstrated their qualifications to operate any single

- vehicle, except those vehicles requiring a Class M

 qualification, with a gross vehicle weight rating of not more

 than 26,000 pounds or any combination of vehicles, except

 combination vehicles involving motorcycles, that does not

 meet the definition of either Class A or Class B of this

 section.
 - (i) Where required under this title, appropriate endorsements must be obtained.
 - (ii) Any firefighter who is the holder of a Class C license and who has a certificate of authorization from his fire chief shall be authorized to operate any fire or emergency vehicle registered to the fire department or municipality, regardless of the other requirements of this section as to the class of license required. No fire chief, fire department, including any volunteer fire company, or municipality shall be liable for any civil damages as a result of the issuance of a certificate authorized under this paragraph unless such act constituted a crime, actual fraud, actual malice or willful misconduct.
 - (iii) Any member of a rescue or emergency squad who is the holder of a Class C license and who has a certificate of authorization from the head of the rescue or emergency squad shall be authorized to operate any rescue or emergency vehicle equipped with audible and visual signals registered to the rescue or emergency squad or municipality, regardless of the other requirements of this section as to the class of license required. No head of a rescue or emergency squad, the rescue or emergency squad or municipality shall be liable

for any civil damages as a result of the issuance of a

certificate of authorization under this paragraph unless

such issuance constituted a crime, actual fraud, actual

malice or willful misconduct.

(iv) The holder of a Class C license shall also be authorized to drive a motor-driven cycle with an automatic transmission and cylinder capacity not exceeding 50 cubic centimeters [or], a three-wheeled motorcycle equipped with an enclosed cab or an autocycle, but not a motorcycle unless the license is endorsed, as provided in this title.

(4) Class M.--

- (i) A Class M license shall be issued to those persons who have demonstrated their qualifications to operate a motorcycle. A Class M license accompanied by an endorsement shall be issued to those persons who have demonstrated their qualifications to operate a motordriven cycle. If a person is qualified to operate only a motorcycle or motor-driven cycle, he shall be issued only a Class M license or a Class M license with an endorsement, as applicable.
- 22 <u>(ii) This paragraph shall not apply to an autocycle.</u>

- 28 (g) Autocycles not to be used. -- No applicant for a driver's
- 29 <u>license may use an autocycle for the actual demonstration of</u>
- 30 ability to exercise ordinary and reasonable control in the

- 1 operation of a motor vehicle of the type or class of vehicles
- 2 for which the applicant desires a license to drive.

- 13 (a) Form and content. -- The department shall prepare and upon
- 14 request supply to all law enforcement agencies and other
- 15 appropriate agencies or individuals, forms for written accident
- 16 reports as required in this subchapter suitable with respect to
- 17 the persons required to make the reports and the purposes to be
- 18 served. The written report forms shall call for sufficiently
- 19 detailed information to disclose with reference to a vehicle
- 20 accident the cause, conditions then existing and the persons and
- 21 vehicles involved, including separate information or data on
- 22 <u>autocycles</u>. Reports for use by the drivers and owners shall also
- 23 provide for information relating to financial responsibility.

- 3 including, but not limited to, an analysis of accident
- 4 characteristics and mitigation strategies to reduce the

- 10 <u>shall be separated from information or data relating to other</u>

- 14 (1) This section shall take effect immediately.
- 15 (2) The amendment or addition of 75 Pa.C.S. §§ 3752(a)
- 16 and 3753(b)(7) shall take effect January 1, 2018.

- days.
