## AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 1 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in school directors, providing for 5 school director training programs. 6 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: Section 1. The act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, is amended by adding a 10 11 section to read:
- 12 <u>Section 328. School Director Training Programs.--(a)</u>
- 13 Beginning in the 2017-2018 school year and in each school year
- 14 thereafter, each newly elected or appointed school director
- 15 shall complete, during the first year of the school director's
- 16 first term, a training program developed and made available by
- 17 the Department of Education, in consultation with a Statewide
- 18 <u>organization representing school directors and a Statewide</u>
- 19 organization representing school business officials, pertaining

- 1 to the skills and knowledge necessary to serve as a school
- 2 director. The training program shall consist of eight (8) hours
- 3 of instruction, to include, at a minimum, information regarding
- 4 the following:
- 5 (1) Instruction and academic programs.
- 6 <u>(2) Personnel.</u>
- 7 <u>(3) Fiscal management.</u>
- 8 <u>(4) Operations.</u>
- 9 <u>(5) Governance.</u>
- 10 (b) Within one (1) year after each reelection or
- 11 reappointment to the board of school directors, each school
- 12 <u>director shall complete an advanced training program developed</u>
- 13 and offered by the Department of Education in consultation with
- 14 <u>a Statewide organization representing school directors and a</u>
- 15 Statewide organization representing school business officials.
- 16 The advanced training program shall consist of four (4) hours of
- 17 instruction, including information on relevant changes to
- 18 Federal and State public school law and regulations, fiscal
- 19 management and other information deemed appropriate by the
- 20 Department of Education, to enable the school director to serve
- 21 effectively.
- 22 (c) The Department of Education shall examine options for
- 23 providing the training programs required under this section
- 24 through methods such as online or other distance learning media
- 25 or through regional-based training.
- 26 (d) The training programs required under this section shall
- 27 <u>be developed and offered by the Department of Education at no</u>
- 28 cost to school districts or school directors.
- 29 (e) Each school director who is in office on the effective
- 30 date of this section shall complete the training program

- 1 required under subsection (a) by June 30, 2018.
- 2 Section 2. This act shall take effect immediately.
