A RESOLUTION

1 2 3	Designating the month of October 2015 as "Meet the Blind Month" in Pennsylvania and recognizing October 15, 2015, as "White Cane Safety Day" in Pennsylvania.
4	WHEREAS, The National Federation of the Blind (NFB) was
5	founded in 1940 to end discrimination against people who are
6	blind and to secure first-class citizenship for all blind
7	persons; and
8	WHEREAS, Today the NFB represents more than 50,000 members
9	across this nation and continues to work to secure equal rights
10	and opportunities for all individuals who are blind or visually
11	<pre>impaired; and</pre>
12	WHEREAS, The NFB and other organizations work to change
13	attitudes about blindness by providing information to parents,
14	teachers and school administrators and to businesses, government

1 and social and civic leaders; and

2 WHEREAS, Since blindness is still frequently misunderstood, a 3 public education campaign, Meet the Blind Month, was developed 4 to create opportunities for people to learn firsthand that 5 individuals who are blind or visually impaired are like everyone 6 else; and

7 WHEREAS, The white cane symbolizes the ability of every blind 8 or visually impaired resident of this Commonwealth to achieve a 9 full and independent life; and

10 WHEREAS, The white cane allows every blind or visually impaired person to move freely and safely from place to place 11 12 and without it such travel would be difficult and dangerous; and 13 WHEREAS, The white cane serves as a tangible reminder that those who are blind or visually impaired are self-sufficient, 14 15 mobile and capable of participating in the life of their 16 communities and contributing to the success of our society; and 17 WHEREAS, In the first white cane proclamation issued in 1964, 18 President Lyndon B. Johnson commended blind and visually 19 impaired individuals for their growing spirit of independence 20 and their increased determination to be self-reliant and 21 dignified; and

22 WHEREAS, President Johnson also said that in our society the 23 white cane has become a unique symbol of a blind or visually 24 impaired person's ability to come and go independently and its 25 use has promoted courtesy and opportunity for mobility of people 26 who are blind on our streets and highways; and

27 WHEREAS, The white cane reminds us that when approaching a 28 blind or visually impaired person, we should always exercise 29 appropriate caution, especially if operating an automobile; 30 therefore be it
