A RESOLUTION

- 1 Honoring female veterans who heroically served our country as 2 members of the United States Armed Forces.
- 3 WHEREAS, Women have served in our armed forces since the
- 4 Revolutionary War; and
- 5 WHEREAS, An estimated 435,000 women served in World War I and
- 6 World War II; and
- 7 WHEREAS, While the total veteran population is decreasing,
- 8 the number of female veterans continues to increase; and
- 9 WHEREAS, Between 1990 and 2008, the women veteran population
- 10 increased from 1,200,000 to 1,800,000; and
- 11 WHEREAS, As of September 2015, the total veteran population
- 12 in the United States and Puerto Rico was approximately
- 13 21,680,534, with women numbering 2,035,213; and

- 1 WHEREAS, It is projected that women veterans will represent
- 2 more than 10% of the total veteran population by 2020; and
- 3 WHEREAS, According to the United States Department of
- 4 Veterans Affairs, there are 71,287 female veterans in
- 5 Pennsylvania; therefore be it
- 6 RESOLVED, That the House of Representatives honor female
- 7 veterans who heroically served our country as members of the
- 8 United States Armed Forces.
