## AN ACT

- Providing for portability of professional and occupational licenses for military spouses.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Military
- 7 Spouse License Portability Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Licensing board." A professional or occupational licensing
- 13 board or commission of this Commonwealth, including:
- 14 (1) Navigation Commission for the Delaware River and its
- 15 Navigable Tributaries.
- 16 (2) State Architects Licensure Board.
- 17 (3) State Board of Accountancy.

- 1 (4) State Board of Auctioneer Examiners.
- 2 (5) State Board of Barber Examiners.
- 3 (6) State Board of Certified Real Estate Appraisers.
- 4 (7) State Board of Chiropractic.
- 5 (8) State Board of Cosmetology.
- 6 (9) State Board of Crane Operators.
- 7 (10) State Board of Dentistry.
- 8 (11) State Board of Examiners of Nursing Home
- 9 Administrators.
- 10 (12) State Board of Funeral Directors.
- 11 (13) State Board of Landscape Architects.
- 12 (14) State Board of Massage Therapy.

- 3 "Military spouse." A person who is married to a member of
- 4 the armed forces of the United States or a reserve component of
- 5 the armed forces of the United States under the laws of the
- 6 jurisdiction where the marriage took place.
- 7 Section 3. Requirements for license.
- 8 (a) General rule. -- Notwithstanding any other law, a
- 9 licensing board shall issue a license to a military spouse to
- 10 allow the military spouse to practice the military spouse's
- 11 profession or occupation in this Commonwealth if, upon
- 12 application to the licensing board, the military spouse
- 13 satisfies all of the following conditions:
- 14 (1) Holds a current license, certificate, registration
- or permit from another state, and that state's requirements
- are substantially equivalent to or exceed the requirements
- for a license in this Commonwealth.
- 18 (2) Demonstrates competency in the profession or
- occupation through methods determined by the licensing board,
- 20 including having completed continuing education units or
- 21 having experience in the profession or occupation for at
- least two of the five years preceding the date of the
- 23 application under this act.
- 24 (3) Has not committed any act in any state that would
- 25 have constituted grounds for refusal, suspension or
- 26 revocation of a license to practice that profession or
- occupation in this Commonwealth at the time the act was
- 28 committed.
- 29 (4) Is in good standing and has not been disciplined by
- 30 the jurisdiction that issued the license.

- 1 (5) Pays any fees required by the licensing board from
- which the applicant is seeking a license.
- 3 (b) Rights and obligations. -- A military spouse who is not a
- 4 resident of this Commonwealth and who is issued a license under
- 5 this act shall have the same rights and obligations as a
- 6 resident of this Commonwealth who is issued the same type of
- 7 license.
- 8 Section 4. Provisional license.
- 9 (a) General rule. -- Notwithstanding any other law, a
- 10 licensing board may issue a provisional license to a military
- 11 spouse who is licensed, certified, registered or issued a permit
- 12 in another state while the military spouse is satisfying certain
- 13 requirements, as determined by the licensing board, for a
- 14 license in this Commonwealth under section 3.
- 15 (b) Limited period. -- A military spouse may practice under a
- 16 provisional license issued under subsection (a) until any of the
- 17 following occurs:
- 18 (1) A license is granted or denied by the licensing
- 19 board under section 3.
- 20 (2) The provisional license expires.
- 21 (3) The holder of a provisional license fails to comply
- 22 with its terms.
- 23 Section 5. Alternative procedure for licensure.
- 24 This act may not prohibit a military spouse from proceeding
- 25 under other licensure requirements established by a licensing
- 26 board.
- 27 Section 6. Rules and regulations.
- 28 A licensing board may adopt rules or regulations necessary to
- 29 implement this act.
- 30 Section 7. Effective date.

1 This act shall take effect in 60 days.
