## AN ACT

Amending the act of April 9, 1929 (P.L.177, No.175), entitled "An act providing for and reorganizing the conduct of the 1 2 executive and administrative work of the Commonwealth by the 3 Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or 5 6 Teachers Colleges; abolishing, creating, reorganizing or 7 authorizing the reorganization of certain administrative 8 departments, boards, and commissions; defining the powers and 9 10 duties of the Governor and other executive and administrative officers, and of the several administrative departments, 11 boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive 12 13 and administrative officers; providing for the appointment of 14 15 certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, 16 and commissions; and prescribing the manner in which the 17 number and compensation of the deputies and all other assistants and employes of certain departments, boards and 18 19 commissions shall be determined," in services for the blind 20 and visually impaired, further providing for definitions and 21 for business enterprises, equipment, leases, repayment. 22 23 The General Assembly of the Commonwealth of Pennsylvania 24 hereby enacts as follows: 25 Section 1. The definition of "state property" in section 26 2221 of the act of April 9, 1929 (P.L.177, No.175), known as The

Administrative Code of 1929, added June 22, 1999 (P.L.99,

- 6 "State property" shall mean property owned or leased by the
- 7 State government or an agency of the State government and
- 8 designated by the bureau as appropriate for participation in the

- 11 (1) rest, recreation and safety rest areas on the national
- 12 system of interstate and defense highways;
- 13 (2) institutions of higher learning except as provided in

- 15 (3) institutions of the Department of Corrections[.]; or
- 16 (4) State veterans' homes operated by the Department of

- 23 (f) The department is authorized to receive and transmit to
- 24 the State Treasury for credit to the fund all money received by
- 25 the Commonwealth on account of contracts between the
- 26 Commonwealth, acting through the Department of General Services,
- 27 and vending machine owners, whereby the Commonwealth is to
- 28 receive a percentage of the profits from vending machines
- 29 operated in State buildings, except for those vending machines
- 30 in State veterans' homes and State buildings in which a

- 3 Section 3. This act shall take effect immediately.
