AN ACT

- Amending the act of July 9, 1987 (P.L.220, No.39), entitled "An 1
- act licensing and regulating the practice of social work;
- providing penalties; and making an appropriation," further
- providing for definitions, for reciprocity, for restriction
- on the use of title "licensed clinical social worker," for penalties and for unlawful practice; and repealing provisions 5
- 6
 - related to appropriation.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:

- 10 Section 1. Section 3 of the act of July 9, 1987 (P.L.220,
- 11 No.39), known as the Social Workers, Marriage and Family
- 12 Therapists and Professional Counselors Act, amended December 21,
- 13 1998 (P.L.1017, No.136), February 13, 2002 (P.L.83, No.4), July
- 9, 2008 (P.L.929, No.68) and October 22, 2014 (P.L.2884,
- 15 No.179), is amended to read:
- 16 Section 3. Definitions.
- 17 The following words and phrases when used in this act shall
- 18 have the meanings given to them in this section unless the
- context clearly indicates otherwise: 19

- 1 "Application of social work methods and theory." Includes
- 2 psychosocial assessment, crisis intervention, case management,
- 3 client-centered advocacy, psychotherapy and family therapy with
- 4 individuals, couples, families and groups in an effort to
- 5 prevent or ameliorate family and personal dysfunction at home,
- 6 at work and in the community.
- 7 "Board." The State Board of Social Workers, Marriage and
- 8 Family Therapists and Professional Counselors under the Bureau
- 9 of Professional and Occupational Affairs within the Department
- 10 of State.
- 11 "Client." A person with whom a licensee has established a
- 12 <u>formal provider-client relationship and to whom the licensee is</u>
- 13 providing, or has provided, professional services.
- 14 "Commissioner." The Commissioner of Professional and
- 15 Occupational Affairs.
- 16 "Independent practice of clinical social work." The
- 17 <u>application of clinical social work knowledge and skills by a</u>
- 18 licensed clinical social worker who regulates and is responsible
- 19 for his or her own practice and treatment procedures.
- "Licensed bachelor social worker." A social worker who holds
- 21 a current bachelor's level license under this act.
- "Licensed clinical social worker." [A social worker] An_
- 23 <u>individual who engages in or advertises to engage in the</u>
- 24 practice of clinical social work and who holds a current
- 25 clinical license under this act.
- 26 "Licensed marriage and family therapist." An individual who
- 27 engages in or offers to engage in the practice of marriage and
- 28 family therapy and who holds a current license under this act.
- "Licensed professional counselor." An individual who engages
- 30 in the practice of professional counseling and who holds a

- 1 current license under this act.
- 2 "Licensed social worker." [A social worker] An individual
- 3 who engages in or advertises to engage in the practice of social
- 4 work and who holds a current license under this act.
- 5 "Practice of bachelor social work." The professional
- 6 application of social work theory, knowledge, methods,
- 7 principles, values and ethics to restore or enhance social or
- 8 psychosocial functioning of individuals, couples, families,
- 9 groups, organizations and communities. This practice is basic
- 10 generalist nonclinical practice that includes interviewing,
- 11 planning, intervention, case management, mediation, supportive
- 12 counseling, information and referral, problem solving, client
- 13 education, advocacy, community organization and the development,
- 14 implementation and administration of policies, programs and
- 15 activities.
- 16 "Practice of clinical social work." Holding oneself out to
- 17 the public by any title or description of services incorporating
- 18 the term "licensed clinical social worker" or using any words or
- 19 symbols indicating or tending to indicate that one is a licensed
- 20 clinical social worker and under such description offering to
- 21 render or rendering a service in which a special knowledge of
- 22 social resources, human personality and capabilities and
- 23 therapeutic techniques is directed at helping people to achieve
- 24 adequate and productive personal, interpersonal and social
- 25 adjustments in their individual lives, in their families and in
- 26 their community. The term includes person and environment
- 27 perspectives, systems theory and cognitive/behavioral theory, to
- 28 the assessment, diagnosis and treatment of psychosocial
- 29 disability and impairment, including mental and emotional
- 30 disorders, developmental disabilities and substance abuse. The

- 1 term includes the application of social work methods and theory.
- 2 The term includes the practice of social work plus additional
- 3 concentrated training and study as defined by the board by
- 4 regulation.
- 5 "Practice of marriage and family therapy." The professional
- 6 application of psychotherapeutic and family systems theories and
- 7 techniques to the evaluation, assessment and treatment of mental
- 8 and emotional disorders, whether cognitive, affective or
- 9 behavioral. The term includes the evaluation and assessment of
- 10 mental and emotional disorders in the context of significant
- 11 interpersonal relationships and the delivery of
- 12 psychotherapeutic services to individuals, couples, families and
- 13 groups for the purpose of treating such disorders.
- "Practice of professional counseling." Includes, to the
- 15 extent compatible with a practitioner's education and
- 16 professional competence, all of the following:
- 17 (1) The application of principles and practices of
- 18 counseling, mental health and human development to evaluate
- and facilitate human growth and adjustment throughout the
- 20 life span and to prevent and treat mental, emotional or
- 21 behavioral disorders and associated stresses which interfere
- 22 with mental health and normal human growth and development.
- 23 (2) The evaluation and assessment of normal and abnormal
- 24 mental, emotional, social, educational, vocational, family
- and behavioral functioning throughout the life span;
- 26 individual, group, family counseling and psychotherapy;
- 27 crisis intervention, career counseling and educational and
- vocational counseling; functional assessment of persons with
- 29 disabilities; and professional consulting.
- 30 (3) Professional counselors' utilization of verbal and

- 1 nonverbal approaches and specialization in the use of arts-
- 2 based therapeutic approaches, such as art, dance, music or
- drama, to accomplish treatment objectives.
- 4 "Practice of social work." Offering to render or rendering a
- 5 service in which a special knowledge of social resources, human
- 6 personality and capabilities and therapeutic techniques is
- 7 directed at helping people to achieve adequate and productive
- 8 personal, interpersonal and social adjustments in their
- 9 individual lives, in their families and in their community or
- 10 holding oneself out to the public by any title or description of
- 11 services incorporating the term "social worker" or using any
- 12 words or symbols indicating or tending to indicate that one is a
- 13 social worker, except as otherwise provided by this act.
- "Social worker." A person who holds a current license under
- 15 this act or has received a bachelor's, master's or doctoral
- 16 degree from an accredited school or program of social work or
- 17 social welfare.
- 18 Section 2. Section 10 of the act, amended October 22, 2014
- 19 (P.L.2884, No.179), is amended to read:
- 20 Section 10. Reciprocity.
- 21 (a) General rule. -- The board shall have the power to grant a
- 22 reciprocal license to an applicant who is licensed or certified
- 23 as a bachelor social worker, social worker, clinical social
- 24 worker, marriage and family therapist or professional counselor
- 25 in another state and has demonstrated qualifications which equal
- 26 or exceed those required pursuant to this act in the
- 27 determination of the board, provided that no license shall be
- 28 granted under this section to an applicant unless the state in
- 29 which the applicant is licensed affords reciprocal treatment to
- 30 persons who are residents of this Commonwealth and who are

- 1 licensed pursuant to this act.
- 2 (b) Emergencies. -- The board shall have the power to allow an
- 3 individual who is licensed or certified as a clinical social
- 4 worker in another state to practice in this Commonwealth without
- 5 licensure for no more than 60 days as part of a relief effort
- 6 <u>related to a state of emergency as declared by the Federal</u>
- 7 Government or the Governor.
- 8 Section 3. Section 16.1 of the act, added December 21, 1998
- 9 (P.L.1017, No.136), is amended to read:
- 10 Section 16.1. Restriction on the use of title "Licensed
- 11 Clinical Social Worker."
- 12 Only individuals who have received licenses as licensed
- 13 clinical social workers under this act may style themselves as
- 14 licensed clinical social workers and use the letters "L.C.S.W."
- 15 in connection with their names. It shall be unlawful for an
- 16 individual to style oneself as a licensed clinical social
- 17 worker, advertise or engage in the independent practice of
- 18 <u>clinical social work</u> or use any words or symbols indicating or
- 19 tending to indicate that the individual is a licensed clinical
- 20 social worker without holding a license in good standing under
- 21 this act.
- Section 4. Sections 17(b) and 20(a) of the act, amended
- 23 October 22, 2014 (P.L.2884, No.179), are amended to read:
- 24 Section 17. Penalties.
- 25 * * *
- 26 (b) Civil penalty. -- In addition to any other civil remedy or
- 27 criminal penalty provided for in this act, the board, by a vote
- 28 of the majority of the maximum number of the authorized
- 29 membership of the board as provided by law, or by a vote of the
- 30 majority of the duly qualified and confirmed membership or a

- 1 minimum of three members, whichever is greater, may levy a civil
- 2 penalty of up to \$1,000 on any current licensee who violates any
- 3 provision of this act, on any person who engages in the
- 4 <u>independent practice of clinical social work without being</u>
- 5 licensed pursuant to this act or on any person who holds himself
- 6 or herself out as a licensed bachelor social worker, licensed
- 7 social worker, licensed clinical social worker, licensed
- 8 marriage and family therapist or licensed professional counselor
- 9 without being so licensed pursuant to this act. The board shall
- 10 levy this penalty only after affording the accused party the
- 11 opportunity for a hearing, as provided in Title 2 of the
- 12 Pennsylvania Consolidated Statutes (relating to administrative
- 13 law and procedure).

- 15 Section 20. Unlawful practice.
- 16 (a) Unlawful practice prohibited. -- It shall be unlawful for
- 17 any person to engage in the independent practice of clinical
- 18 <u>social work or</u> hold himself or herself out as a licensed
- 19 bachelor social worker, licensed social worker, licensed
- 20 clinical social worker, marriage and family therapist and
- 21 professional counselor without possessing a valid, unexpired,
- 22 unrevoked and unsuspended license issued under this act.
- 23 * * *
- 24 Section 5. Section 21 of the act is repealed:
- 25 [Section 21. Appropriation.
- The sum of \$85,000, or as much thereof as may be necessary,
- 27 is hereby appropriated from the Professional Licensure
- 28 Augmentation Account within the General Fund to the Bureau of
- 29 Professional and Occupational Affairs in the Department of State
- 30 for the payment of costs of processing licenses and renewals,

- 1 for the operation of the board and for other general costs of
- 2 the bureau operations relating to this act. The appropriation
- 3 granted shall be repaid by the board within three years of the
- 4 beginning of issuance of licenses by the board.]
- 5 Section 6. This act shall take effect in 120 days.
