- THE OVERPASS ON STATE ROUTE 3145 OVER INTERSTATE 376, BMS 02-29 3145-0010-0537, IN THE MARKET DISTRICT AT SETTLERS RIDGE, 30 31 ROBINSON TOWNSHIP, ALLEGHENY COUNTY, AS THE ROY F. JOHNS, JR., OVERPASS. 32
- A PORTION OF STATE ROUTE 51 IN THE BOROUGH OF CORAOPOLIS, 33
- ALLEGHENY COUNTY, AS THE FRED A. TRELLO MEMORIAL BOULEVARD. 34
- A CERTAIN INTERCHANGE IN NEW STANTON BOROUGH, WESTMORELAND

- 1 COUNTY, AS THE EDWIN "LANCE" WENTZEL MEMORIAL INTERCHANGE.
- THE BRIDGE CARRYING STATE ROUTE 2005 (BUSINESS ROUTE 222) OVER THE SCHUYLKILL RIVER, RIVERFRONT DRIVE AND NORFOLK SOUTHERN
- THE SCHUYLKILL RIVER, RIVERFRONT DRIVE AND NORFOLK SOUTHE RAILROAD IN THE CITY OF READING, BERKS COUNTY, COMMONLY
- 5 REFERRED TO AS THE BINGAMAN STREET BRIDGE, AS THE 65TH U.S.
- 6 INFANTRY REGIMENT, BORINQUENEERS MEMORIAL BRIDGE.
- A BRIDGE ON THAT PORTION OF STATE ROUTE 36 OVER CHEST CREEK, PATTON BOROUGH, CAMBRIA COUNTY, AS THE MARTIN JOSEPH DAVIS MEMORIAL BRIDGE.
- 10 A PORTION OF STATE ROUTE 1008 IN FAYETTEVILLE, FRANKLIN COUNTY,
 11 AS THE JAMES W. CUTCHALL MEMORIAL HIGHWAY.
- 12 A BRIDGE ON THAT PORTION OF U.S. ROUTE 15 OVER STATE ROUTE 114,
- 13 MECHANICSBURG BOROUGH, CUMBERLAND COUNTY, AS THE CORPORAL
- 14 JONATHAN DEAN FAIRCLOTH MEMORIAL BRIDGE.
- 15 The General Assembly of the Commonwealth of Pennsylvania
- 16 hereby enacts as follows:
- 17 Section 1. Battery B Memorial Highway.
- 18 (a) Findings.--The General Assembly finds and declares as
- 19 follows:
- 20 (1) On the morning of June 8, 1861, the Mount Jackson
- 21 Guards of Mount Jackson, Lawrence County, gathered at the
- 22 Mount Jackson Methodist Episcopal Church on present-day State
- Route 108 to bid goodbye to loved ones before going off to
- 24 fight in the Civil War, which many believed would be a grand
- adventure.
- 26 (2) These men were farmers, school teachers, clerks and
- laborers from North Beaver Township, Little Beaver Township,
- 28 Mahoning Township, New Castle and other areas of Lawrence
- 29 County.
- 30 (3) The gathering point is now the site of the Battery B
- 31 Monument placed by veterans in 1923, which sits on the west
- 32 side of Battery B Cemetery, also known as Mt. Jackson M.E.
- 33 Cemetery, to commemorate this event.
- 34 (4) The group of more than 80 young men started off on
- foot for the nine-mile journey to the railroad station in
- 36 Enon, traveling on present-day State Routes 108 and 551,

- being hailed by local supporters as they began their epic
 journey, and sometimes being offered wagon rides from local
 farmers to ease their trip to Enon.
 - (5) The Mount Jackson Guards, later designated Battery B, First Pennsylvania Light Artillery, along with many other Lawrence County regiments, boarded the train to Camp Wright, Camp Wilkins and other training camps in the Pittsburgh area to prepare themselves for Camp Curtin in Harrisburg and to fight the bloodiest battles of the Civil War.
 - (6) Battery B distinguished itself in major battles, such as Fredericksburg, Antietam, Gettysburg and Petersburg, and because they served until Lee's surrender at Appomattox in April 1865, they hold the record for the highest amount of casualties of any artillery unit in the Civil War.
 - (7) Many members of Battery B were present in the Grand Review of Troops in Washington, DC, and from 1869 to 1930, Battery B held elaborate reunions in Mount Jackson, including locals, Lawrence County residents, State dignitaries, military officers, Battery B members from almost every county in Pennsylvania and most of the 48 states, as well as veterans from other Pennsylvania regiments.
 - (8) As many as 2,000 people gathered in the little village of Mount Jackson to honor this illustrious group of men, to hear speeches by the members that reminisced about their experiences and to join in a picnic prepared by the proud citizens of the town.
 - (9) Recently, an article from the New Castle News was discovered, reporting that on September 26, 1925, a parade was given to celebrate the completion of the concrete road from Derringer's Corners, North Beaver Township, continuing

- 1 to the village of Enon Valley, Little Beaver Township.
- 2 (10) The article suggested on that historic occasion
- 3 that State Routes 108 and 551 from Mount Jackson to Enon
- 4 Valley be named the "Battery B Highway."
- 5 (11) The members of the Enon Valley Community Historical
- 6 Society have proposed that this old suggestion made 90 years
- 7 ago become a reality.
- 8 (b) Designation. -- The section of State Routes 108 and 551 in
- 9 Lawrence County from the intersection of State Route 108 and Old
- 10 Hickory Road at the Battery B Monument to State Route 551 ending
- 11 at the railroad tracks of the Pennsylvania Railroad in Enon
- 12 Valley, is hereby designated the Battery B Memorial Highway.
- 13 (c) Signs. -- The Department of Transportation shall erect and
- 14 maintain appropriate signs displaying the name of the highway to

- 25 PASSENGER ON LANDING CRAFT UTILITY #63 THAT CAPSIZED FIVE
- 26 NAUTICAL MILES SOUTH OF THE PORT AT TAN MY, VIETNAM. HIS
- 27 REMAINS WERE NOT RECOVERED.
- 28 (B) DESIGNATION.--THE BRIDGE LOCATED ON STATE ROUTE 403 IN
- 29 THE BOROUGH OF CLYMER, INDIANA COUNTY, OVER THE TWO LICK CREEK
- 30 IS HEREBY DESIGNATED THE SERGEANT JAMES ROBERT PANTALL MEMORIAL

- 2 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
- 3 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE BRIDGE TO

- 5 SECTION 3. AIRMAN SECOND CLASS GERALD EMMETT JOHNSON MEMORIAL
- 6 BRIDGE.
- 7 (A) FINDINGS.--THE GENERAL ASSEMBLY FINDS AND DECLARES AS
- 8 FOLLOWS:
- 9 (1) AIRMAN SECOND CLASS GERALD EMMETT JOHNSON OF ARCADIA
- 10 WAS A CREW MEMBER OF A B-29A SUPERFORTRESS BOMBER WITH THE
- 371ST BOMBER SQUADRON, 307TH BOMBER WING DURING THE KOREAN
- 12 WAR.
- 13 (2) ON OCTOBER 23, 1951, THE AIRCRAFT WAS SHOT DOWN BY
- 14 ENEMY MIGS OVER NAMSI AIRFIELD AND AIRMAN SECOND CLASS
- JOHNSON WAS TAKEN AS A PRISONER OF WAR.
- 16 (3) AIRMAN SECOND CLASS JOHNSON WAS DECLARED DEAD ON
- 17 JANUARY 28, 1954.
- 18 (4) AIRMAN SECOND CLASS JOHNSON WAS AWARDED THE AIR
- 19 MEDAL, THE PURPLE HEART, THE PRISONER OF WAR MEDAL, THE
- 20 KOREAN SERVICE MEDAL, THE UNITED NATIONS SERVICE MEDAL, THE
- 21 NATIONAL DEFENSE SERVICE MEDAL, THE KOREAN PRESIDENTIAL UNIT
- 22 CITATION AND THE REPUBLIC OF KOREA WAR SERVICE MEDAL.
- 23 (B) DESIGNATION.--THE BRIDGE LOCATED ON STATE ROUTE 580 OVER
- 24 THE SUSQUEHANNA RIVER IN CHERRY TREE BOROUGH, INDIANA COUNTY, IS
- 25 HEREBY DESIGNATED THE AIRMAN SECOND CLASS GERALD EMMETT JOHNSON
- 26 MEMORIAL BRIDGE.
- 27 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
- 28 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE BRIDGE TO
- 29 TRAFFIC IN BOTH DIRECTIONS ON THE BRIDGE.
- 30 SECTION 4. PRIVATE WALTER L. SMITH SPANISH-AMERICAN WAR

- 1 MEMORIAL BRIDGE.
- 2 (A) FINDINGS.--THE GENERAL ASSEMBLY FINDS AND DECLARES AS
- 3 FOLLOWS:
- 4 (1) PRIVATE WALTER L. SMITH WAS BORN ON APRIL 27, 1877,
- 5 IN MUNCY, LYCOMING COUNTY. HE WAS THE SON OF DAVID S. SMITH,
- 6 A CIVIL WAR VETERAN, AND HANNAH (COLLEY) SMITH. PRIVATE SMITH
- 7 SERVED IN THE SPANISH-AMERICAN WAR AND THE PHILIPPINE
- 8 INSURRECTION.
- 9 (2) PRIVATE SMITH FIRST ENTERED THE SERVICE AT
- 10 WILLIAMSPORT ON MAY 7, 1898, AND MUSTERED INTO SERVICE MAY
- 11 12, 1898, AS A PRIVATE IN COMPANY D, 12TH PENNSYLVANIA
- 12 VOLUNTEER INFANTRY. HE MUSTERED OUT AND WAS HONORABLY
- 13 DISCHARGED ON NOVEMBER 1, 1898.
- 14 (3) PRIVATE SMITH REENLISTED ON NOVEMBER 11, 1898, AT
- 15 PHILADELPHIA DURING THE TIME OF THE PEACE JUBILEE, WITH THE
- RANK OF PRIVATE IN THE U.S. ARMY, COMPANY I, 1ST U.S.
- 17 VOLUNTEER INFANTRY, AS A MEMBER OF THE FOOT SERVICE, HEAVY
- 18 ARTILLERY. FROM DECEMBER 29, 1898, TO SEPTEMBER 6, 1900, HE
- 19 WAS ASSIGNED TO GUANAJAY BARRACKS, CUBA. HE ARRIVED IN THE
- 20 PHILIPPINES ON APRIL 15, 1901.
- 21 (4) ON JULY 28, 1901, WHILE ON A SUPPLY PATROL WITH A
- 22 SMALL DETACHMENT, PRIVATE SMITH BRAVELY AND SELFLESSLY
- 23 DEFENDED MEMBERS OF HIS COMPANY AGAINST AN OVERWHELMING
- 24 AMBUSH ATTACK BY APPROXIMATELY 60 NATIVE INSURGENTS AT DON
- 25 CARLON, SAMAR, PHILIPPINE ISLANDS. DURING THE ENGAGEMENT, HIS
- 26 SERGEANT, THE ONLY OTHER MAN WHO WAS ARMED, WAS SHOT AND
- 27 KILLED BY THE INSURGENTS. AS PRIVATE SMITH COURAGEOUSLY AND
- 28 FEARLESSLY FOUGHT ALONE, TWO UNARMED SOLDIERS WERE ABLE TO
- 29 ESCAPE AND RETURN TO CAMP. PRIVATE SMITH WAS SOON OVERPOWERED
- 30 BY THE ENEMY AND SEVERELY WOUNDED, BEING STABBED SEVERAL

- 1 TIMES. HE WAS CAPTURED AND TAKEN PRISONER. THE U.S. ARMY
- 2 CONDUCTED MULTIPLE SEARCHES TO LOCATE PRIVATE SMITH.
- 3 (5) PRIVATE WALTER L. SMITH WAS LISTED AS MISSING IN
- 4 ACTION UNTIL FEBRUARY 10, 1902, WHEN THE FACT WAS
- 5 ESTABLISHED, BEYOND A DOUBT, THAT HE HAD MET HIS DEATH AT THE
- 6 HANDS OF THE INSURGENTS ON THE DATE OF HIS CAPTURE, JULY 28,
- 7 1901. HIS REMAINS WERE NEVER RECOVERED FOR RETURN HOME TO HIS
- 8 FAMILY IN MUNCY.
- 9 (B) DESIGNATION.--THE BRIDGE ON STATE ROUTE 2014 OVER THE
- 10 MUNCY CREEK IN MUNCY CREEK TOWNSHIP, LYCOMING COUNTY, IS HEREBY
- 11 DESIGNATED THE PRIVATE WALTER L. SMITH SPANISH-AMERICAN WAR
- 12 MEMORIAL BRIDGE.
- 13 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
- 14 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE BRIDGE TO
- 15 TRAFFIC IN BOTH DIRECTIONS ON THE BRIDGE.
- 16 SECTION 5. LANCE CORPORAL WILLIAM F. MERRILL VIETNAM VETERANS
- 17 HIGHWAY.
- 18 (A) FINDINGS.--
- 19 (1) LANCE CORPORAL WILLIAM FRANKLIN MERRILL WAS BORN
- 20 AUGUST 20, 1948, IN MUNCY, LYCOMING COUNTY, PENNSYLVANIA, TO
- 21 JOSEPH A. AND SHEILA (WOLFE) MERRILL.
- 22 (2) LANCE CORPORAL MERRILL WAS A RESIDENT OF MUNCY,
- 23 PENNSYLVANIA, BEFORE ENLISTING IN THE UNITED STATES MARINE
- 24 CORPS ON MAY 6, 1968, AT 20 YEARS OF AGE.
- 25 (3) LANCE CORPORAL MERRILL WAS ASSIGNED TO INDIA
- 26 COMPANY, THIRD BATTALION, FIRST MARINES IN VIETNAM AS A
- 27 RADIOMAN.
- 28 (4) ON MAY 12, 1969, WHILE ON A SEARCH AND CLEAR
- 29 MISSION, LANCE CORPORAL MERRILL'S COMPANY CAME UNDER HEAVY
- 30 ENEMY SMALL ARMS AND REPEATING FIRE.

- 1 (5) WITH COMPLETE DISREGARD FOR HIS OWN PERSONAL SAFETY,
- 2 LANCE CORPORAL MERRILL RAN ACROSS OPEN AND FIRE-SWEPT TERRAIN
- 3 TO RETRIEVE A FALLEN COMRADE.
- 4 (6) LANCE CORPORAL MERRILL IMMEDIATELY ADMINISTERED
- 5 FIRST AID TO THE WOUNDED MARINE AND CARRIED THE MARINE TO A
- 6 SAFER AREA WHERE HE COULD RECEIVE FURTHER TREATMENT, HELPING
- 7 TO SAVE HIS LIFE.
- 8 (7) ON AUGUST 7, 1969, LANCE CORPORAL MERRILL HIMSELF
- 9 WAS WOUNDED BUT RETURNED TO DUTY.
- 10 (8) ON NOVEMBER 26, 1969, THE FIRST SQUAD OF THE THIRD
- 11 PLATOON, INCLUDING SQUAD LEADERS AND LIEUTENANTS, WAS SENT ON
- 12 A SPECIAL NIGHT ACTIVITY TO CONDUCT AN AMBUSH.
- 13 (9) AFTER THE AMBUSH, AS NINE MARINES WERE RETURNING TO
- 14 THEIR COMPANY'S POSITION, A WIRE ATTACHED TO A BOOBY TRAP WAS
- 15 TRIPPED.
- 16 (10) LANCE CORPORAL MERRILL GUARDED THE DEVICE AND
- 17 CALLED FOR HIS SERGEANT AS THE REST OF THE MARINES MADE THEIR
- 18 WAY THROUGH THE DANGER AREA.
- 19 (11) AFTER THE OTHER MARINES HAD SAFELY CROSSED THE
- 20 RAVINE WHERE THE BOOBY TRAP WAS LOCATED, THE DEVICE
- 21 DETONATED, KILLING LANCE CORPORAL MERRILL INSTANTLY AND
- 22 FATALLY WOUNDING HIS SERGEANT.
- 23 (B) DESIGNATION.--THE SECTION OF STATE ROUTE 2044 IN
- 24 LYCOMING COUNTY FROM THE BRIDGE OVER GLADE RUN TO THE
- 25 INTERSECTION OF STATE ROUTES 405 AND 422 IS HEREBY DESIGNATED

- 3 (1) BRIAN K. MOWERY WAS BORN ON DECEMBER 30, 1961, TO
- 4 HARRY E. AND PATRICIA M. MOWERY.
- 5 (2) STAFF SERGEANT MOWERY SERVED IN THE UNITED STATES
- 6 MARINE CORPS FROM 1979 THROUGH 1985.
- 7 (3) IN 2000, STAFF SERGEANT MOWERY ENLISTED IN THE
- 8 PENNSYLVANIA ARMY NATIONAL GUARD KUTZTOWN AS AN INFANTRY
- 9 TEAM LEADER AND A MOTOR TRANSPORT OPERATOR. DURING THIS TIME,
- 10 HE SERVED IN THE KOSOVO PEACEKEEPING MISSION FROM 2003
- 11 THROUGH 2004 AND IN DISASTER RELIEF AFTER HURRICANE KATRINA
- 12 IN 2005.
- 13 (4) STAFF SERGEANT MOWERY PROUDLY SERVED IN THE 131ST
- 14 TRANSPORTATION COMPANY OF THE PENNSYLVANIA ARMY NATIONAL
- 15 GUARD WILLIAMSTOWN STARTING IN 2010 AND WAS STATIONED IN
- 16 AFGHANISTAN FROM JANUARY 2011 UNTIL HIS DEATH.
- 17 (5) WHILE TRANSPORTING NECESSARY SUPPLIES NEAR BAGRAM,
- 18 AFGHANISTAN, HIS CONVOY WAS ATTACKED, AND STAFF SERGEANT
- 19 MOWERY WAS KILLED ON JULY 18, 2011.
- 20 (6) IN RECOGNITION OF HIS SERVICE, STAFF SERGEANT MOWERY
- 21 WAS AWARDED TWO ARMY COMMENDATION MEDALS, AN ARMY RESERVE
- 22 COMPONENT ACHIEVEMENT MEDAL, A NATO MEDAL, THE KOSOVO
- 23 CAMPAIGN MEDAL AND THE GOVERNOR'S UNIT CITATION. HE
- 24 POSTHUMOUSLY RECEIVED THE PURPLE HEART AND THE BRONZE STAR,
- 25 AND HE WAS PROMOTED TO THE RANK OF STAFF SERGEANT.
- 26 (B) DESIGNATION.--THE BRIDGE ON STATE ROUTE 225 THAT CROSSES
- 27 THE ARMSTRONG CREEK IN HALIFAX TOWNSHIP, DAUPHIN COUNTY, IS
- 28 HEREBY DESIGNATED AS THE STAFF SERGEANT BRIAN K. MOWERY MEMORIAL
- 29 BRIDGE.
- 30 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND

- 1 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE BRIDGE TO

- 4 (A) FINDINGS.--THE GENERAL ASSEMBLY FINDS AND DECLARES AS
- 5 FOLLOWS:
- 6 (1) SAMUEL L. SNYDER WAS BORN ON FEBRUARY 12, 1882, IN
- 7 EAST COCALICO TOWNSHIP, LANCASTER COUNTY. MR. SNYDER WAS A
- 8 BUILDING CONTRACTOR, DEVELOPER AND REALTOR IN DENVER,
- 9 PENNSYLVANIA, FOR NEARLY SIX DECADES. IT IS ESTIMATED THAT HE
