AN ACT

- Amending Title 30 (Fish) of the Pennsylvania Consolidated Statutes, in Pennsylvania Fish and Boat Commission, providing for power to set fees; in fiscal affairs, further providing for collection fee for uncollectible checks; in fishing licenses, further providing for nonresident and tourist licenses, for one-day resident fishing license, for license, permit and issuing agent fees and for license and permit 7 packaging options; in special licenses and permits, further 8 providing for net permits, for boat and net licenses for 9 boundary lakes, for permits for protection and management of 10 particular fish, for permits for the use of explosives, for 11 Lake Erie fishing permits and for fishing guide and charter 12 boat permits; in regulated fishing lakes, further providing for licenses and for fees; in dams, bar racks and migration devices, further providing for obstructing migration of fish; 13 14 15 in preliminary provisions, further providing for fees; and, 16 17 in registration and titling of boats, further providing for issuing agents, for fees and for notice for boats and related 18 19 equipment.
- 20 The General Assembly of the Commonwealth of Pennsylvania
- 21 hereby enacts as follows:
- 22 Section 1. Title 30 of the Pennsylvania Consolidated

2	(1) Beginning July 1, 2016, the commission, in
3	accordance with paragraph (2), may change or set the fees
4	provided under any of the following:
5	(i) Section 502 (relating to service charge for
6	uncollectible checks).
7	(ii) Section 2715(a)(1), (2), (3), (4), (5), (6),
8	(6.1), (6.2) and (7), (a.1)(1), (4) and (5) and (b)
9	(relating license, permit and issuing agent fees).
10	(iii) Section 2902 (relating to net permits).
11	(iv) Section 2903 (relating to boat and net licenses
12	for boundary lakes).
13	(v) Section 2906 (relating to permits for use of
14	explosives).
15	(vi) Section 3102 (relating to fees).
16	(vii) Section 3509 (relating to obstructing
17	migration of fish).
18	(viii) Section 5104 (relating to fees).
19	(ix) Section 5304 (relating to issuing agents).
20	(x) Section 5327 (relating to fees).
21	(xi) Section 5334 (relating to notice for boats and
22	related equipment).
23	(2) A change or setting of a fee under this subsection
24	shall be done as follows:
25	(i) The commission shall publish a notice of
26	proposed rulemaking containing the proposed fee change in
27	accordance with section 201 of the act of July 31, 1968
28	(P.L.769, No.240), referred to as the Commonwealth
29	Documents Law. The commission shall give at least 30 days
30	for the submission of written comments and shall hold at

_	reast one public hearing on the proposed change.
2	(ii) Prior to adoption of a final-form regulation
3	containing a fee change, the commission shall review and
4	consider any public comments and may modify the text of
5	the final-form regulation as the commission deems
6	necessary under section 202 of the Commonwealth Documents
7	Law.
8	(iii) After adoption of a final-form regulation
9	containing a fee change, the commission shall submit the
10	final-form regulation, copies of all public comments and
11	the transcript of the public hearing to the Game and
12	Fisheries Committee of the Senate and the Game and
13	Fisheries Committee of the House of Representatives.
14	(iv) Either committee under subparagraph (iii) may
15	report a concurrent resolution recommending disapproval
16	of the fee change within 30 days of the submission under
17	subparagraph (iii) OR WITHIN 10 LEGISLATIVE SESSION DAYS, <
18	WHICHEVER IS LATER. If neither committee reports a
19	concurrent resolution recommending disapproval within the
20	time prescribed in this subparagraph, the fee change
21	shall be deemed approved.
22	(v) If either committee reports a concurrent
23	resolution under subparagraph (iv) and the General
24	Assembly does not adopt the concurrent resolution within
25	30 days of the date on which the concurrent resolution is
26	reported OR WITHIN 10 LEGISLATIVE DAYS, WHICHEVER IS <
27	LATER, the fee change shall be deemed approved.
28	(vi) If the General Assembly adopts a concurrent
29	resolution under subparagraph (iv) within 30 days of the
30	date on which the concurrent resolution is reported OR <

Τ	WITHIN 10 LEGISLATIVE SESSION DAYS, WHICHEVER IS LATER,
2	the following shall apply:
3	(A) The concurrent resolution shall be presented
4	to the Governor in accordance with section 9 of
5	Article III of the Constitution of Pennsylvania.
6	(B) If the Governor does not veto the concurrent
7	resolution of the General Assembly within ten days
8	after the resolution is presented, the fee change
9	shall be deemed disapproved.
10	(C) If the Governor vetoes the concurrent
11	resolution within ten days after the resolution is
12	presented, the General Assembly may override the veto
13	by a two-thirds vote in each house within 30 days
14	after the veto OR WITHIN 10 LEGISLATIVE SESSION DAYS, <-
15	WHICHEVER IS LATER. If the General Assembly does not
16	override the veto in the time prescribed in this
17	clause, the fee change shall be deemed approved. If
18	the General Assembly overrides the veto in the time
19	prescribed in this clause, the fee change shall be
20	deemed disapproved.
21	(vii) If the fee change is deemed approved under
22	subparagraph (iv), (v) or (vi)(C), the commission shall:
23	(A) submit the final-form regulation containing
24	the fee change to the Office of Attorney General for
25	approval as to the legality; and
26	(B) publish an order adopting the final-form
27	regulation containing the fee change and deposit a
28	copy of the final-form regulation with the
29	Legislative Reference Bureau in accordance with
30	section 207 of the Commonwealth Documents Law.

- 1 (b) Expiration. -- Subsection (a) shall expire July 15, 2019.
- 2 Upon expiration, final-form regulations promulgated under
- 3 subparagraph (vii) (B) shall remain in effect.
- 4 (c) Notice. -- The commission shall provide notice of any
- 5 change of a fee and shall publish the change of the fee in the
- 6 Pennsylvania Bulletin and post it on the commission's publicly
- 7 accessible Internet website.

- 9 Title 30 are amended to read:

- 28 fee and issuing agent fee as set forth in section 2715. One-Day
- 29 Tourist Fishing Licenses shall not be issued for fishing during
- 30 the period from March 15 to April 30 of any year. Holders of

- 2 special permits, including [trout/salmon permits to fish for

- 11 The commission may issue permits to use or possess nets
- 12 larger than four feet square or four feet in diameter, or any
- 13 other seine, trawl or gill net in or along waters of this
- 14 Commonwealth. The permits when issued shall specify when and
- 15 where the nets shall be used and for what purposes by the owner
- 16 or the persons in possession thereof at a fee of \$10[.] or as
- 17 otherwise established by the commission in accordance with
- 18 section 322.1 (relating to power to set fees).
- 19 Section 4. Section 2903(b) and (h) of Title 30 are amended
- 20 and the section is amended by adding a subsection to read:
- 21 § 2903. Boat and net licenses for boundary lakes.

- 7 (i) The name, address and telephone number of the marine business.
 - (ii) A description of the boat, including make, model and year, and the hull identification number, a registration number or temporary decal number.
 - (iii) A description of any related equipment.
 - (iv) Notice that the marine business intends to terminate the owner's and lienholder's rights, title and interest in the boat and any related equipment by operation of law under this subchapter.
 - (v) The amount which must be paid to the marine business to redeem the boat and any related equipment as of the date of the notice.
- 20 (2) To the commission indicating that the marine
 21 business intends to terminate all rights, title and interest
 22 in the boat or any related equipment by operation of law
 23 under this subchapter. This notice shall be accompanied by a
 24 fee of \$50 or as otherwise established by the commission in
 25 accordance with section 322.1 (relating to power to set fees)
 26 and shall be on a form prescribed by the commission.
